Madam with due respect, I am priya Klemari, w/o - Sni,
Sanjiv Das, D/o - late Bijay Prasad Das, resident of Maharij
colony, near Shani Mandir, S.M.C. ward No - 4, PO + PS -
Sikaripur, Dist - Darjeeling would like to inform you that
on 19-07-2021 my marriage was solemnized with
Das, D/o - Sni Sitaram Das, resident of Maharij colony,
near Shani Mandir, S.M.C. ward No - 4, PO + PS -
Dist - Darjeeling at my parental house at Tejatala,
PO + PS + Dist - Kishor, in the state of Bihar and after
marriage, my husband and in-law brought me at their
house at Maharij colony and I have started my conjugal
life with the said Sanjiv Das at my matrimonial
house along with other in-laws. After 2 days of marriage
my husband has started to come at house at late night
with drunken condition and brutally conducted intercourse
sexual intercourse and it I denied to do same, the said
Sanjiv Das assaulted me by fist and blows. The said
Sanjiv Das along with his 2 brothers namely Rajiv Das
and Aman Das, sister-in-law namely Bina Das w/o -
Sni Rajiv Das, and maternal ~~uncle~~ ^{aunt}, namely Apha Das, all
are residents of Maharij colony have started torturing
me physically and mentally, not only that they have
snatched my valuable all stricken properties which are
I have got at the time of my marriage from my parent
and relatives and kept under their custody. They
are creating pressure upon me no bring money amounting
to Rs. 5,00,000 for them as because they are not
satisfied with money which they have taken from
my parents at the time of marriage and upon refuse
from me, they are become furious and brutally
beaten me by threatening that they will kill me.

it I will not give them the said money and finally
 no other alternative, I have tolerate their physical and
 mental torture with a hope that they will change
 their character and I will lead my conjugal life
 happily but day by day their torture become increased
 They are also obtained my signature on blank papers
 which are leading with them till today and I am in
 apprehend that they may use the said papers for
 their any illegal gain.

On 23-06-2022 at about 9 pm when my husband
 reached at home, all of sudden, he alongwith his
 brothers, sister-in-law and maternal uncle as mentioned aforesaid
 are without any authentic reason, abusing me and my parents
 in filthy languages and brutally assaulted me and thereafter
 created me from my matrimonial house with levelled wild
 allegations upon my character and threatened me that if
 I will try to enter into the house, they will kill me
 and nobody can do anything against them. In the world
 of outside of my matrimonial house. Several times, I
 requested them to allow me to reside in the house but
 they did not allowed me and also threatening me with
 dire consequences. Today I have again requested them to
 allow me to reside but they denied

 persons.
