Sir,

In producing here with the one arrested accused person namely Passang Sherpa (35 yrs) S/o Pincho Sherpa of Pipe line, Salugara, Near Salugara High School, PS- Bhakti Nagar, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

- 1] 24 (Twenty four) bottles of Royal Blue Whisky, Blended and bottled by Kanchenjunga distilleries & liquors (each bottle containing 750 ML)
- 2] 18 (Eighteen) bottles of Kingfisher strong premium beer (each bottle containing 650 ML.)
- 3] 12 (Twelve) bottles of Tiger XXX Rum, Blended and bottled by Kanchenjunga distilleries & liquors (each bottle containing 750 ML) (Total approx 39 ltrs)

I, ASI Dipak Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 24/06/22 at about 17.35 hrs received a source information that one person namely Passang Sherpa (35 yrs) S/o Pincho Sherpa of Pipe line, Salugara, Near Salugara High School, PS- Bhakti Nagar, Dist- Jalpaiguri has possessed huge amount of liquors in his house for selling the same to the local customers for wrong full gain. This refers to Bhaktinagar PS GDE No. 1229 Date. 24/06/22. Accordingly the information shared before you and as per your kind direction myself along with force left PS to work out the information. At about 17.55 Hrs we reached at the house of the above noted person and as shown and being identified by the source, held raid at his house and apprehend him who disclosed his name and address as noted above. Further maintaining his decency and observing all formalities searched the house and recovered and seized huge amount of above noted liquors. On demand of license and documents in respect of possessing the liquor, he failed to produce the same. On enquiry the apprehended accused person admitted his guilt and confessed that he has possessed the above noted liquors for the purpose of selling to his designed customers for his wrongful gain. He also stated that he has been doing this act illegally since long without any valid licence or documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 18.35 to 19.10 Hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Passang Sherpa (35 yrs) S/o Pincho Sherpa of Pipe line, Salugara, Near Salugara High School, PS- Bhakti Nagar, Dist- Jalpaiguri under proper section of law and arrange for its investigation.
