Sir,

In producing herewith two (02) arrested accused persons namely Pankaj Mahato (28) s/o Ram Chandra Mahato of Ratanlal Busty, Ward No. 01, PS Pradhna Nagar, Dist Darjeeling (ii) Shiba Barman @ Bow (22) s/o Dilip Barman of Durga Guri, Darjeeling More, PS Pradhan Nagar, Dist. Darjeeling along with the following articles under seizure as per seizure list;

1. One iron made improvised one shutter Firearm having its trigger, hammer and firing pin measuring approx. 11 inches (approx.) including its butt, body and barrel. [The articles have been found kept concealed on the right side of waist of accused Pankaj Mahato marked as "Exhibit-A"]
2. One live ammunition inscribed as "KF", "70" and "7" on its percussion cap found inside the right-side pocket of blue color jeans pant of accused Shiba Barman @ Bow (22) & marked as "Exhibit- B"]

I, SI Abhishek Theengh, S/O- Sri Suchandra Kumar Theengh of Pradhan Nagar Police Station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted two (02) arrested accused persons namely Pankaj Mahato (28) and Shiba Barman @ Bow (22) to the effect that today on 22.06.2022 at about 22.20hrs. I received a specific source input that two person is standing at Siliguri Junction near Bus Stand Gate No 02 under Pradhan Nagar PS, for committing heinous crime. The above noted person namely Pankaj Mahato had carried and possesses one small arm & Shiba Barman @ Bow had carried one ammunition with him. The matter was diarized vide Pradhan Nagar PS GDE No. 1391 Dt. 22.06.2022. Accordingly, I informed the matter to the Inspector-in-Charge, Pradhan Nagar Police Station. Subsequently, as per his kind direction myself along with ASI Ashit Singh, CV/128 Ajay Sahani, CV/242 Rakesh Mangar all of Pradhan Nagar PS and along with investigation kit left for Siliguri Junction near Bus Stand Gate No 02 at 22.30 hrs by govt. vehicle to verify the veracity of the information. This refers Pradhan Nagar PS GDE No. 1392 Dt. 22.06.022.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On the way to Siliguri Junction, called upon two witnesses (1) Mohan Mahato S/O - Ramswarup Mahato of Samarnagar PS - Pradhannagar Dist - Darjeeling and (2) Azad Khan S/O- late Abdul Rauf Khan of Biswas Colony P.S- Matigara, Dist- Darjeeling and after disclosing our identity and disclosed the fact I requested them to accompany with us as witnesses. We requested them to search the persons of each Police personnel in our team and nothing could be found except service fire arms and wearing apparels.

Thereafter I along with force reached at Siliguri Junction near Bus Stand Gate No 02 at 22.45hrs. and being pointed by my source apprehended the above noted two accused persons named Pankaj Mahato (28) and Shiba Barman @ Bow (22) and searched them immediately and found the above noted articles from their conscious and exclusive possession. On demand they both failed to produce any document in support of their possessing and carrying of such type of fire arms and ammunitions. Hence, it is evident that the accused persons namely Pankaj Mahato (28) exclusively & consciously possessed this improvised fire arms and Shiba Barman @ Bow (22) Possessed with lone ive ammunition illegally with some ill motive in order to commit crime in the locality.

Thus, both the accused persons involvement in carrying and possessing illegal fire arm and ammunition is established, I seized and labeled the above noted articles at the spot under proper seizure list duly signed by them and also put my signature on the seizure list and label. The seizure time was made between 22.55 to 23.35 hrs. Subsequently, I also arrested him preparing memo of arrest informing him the ground of his arrest.


From the above noted facts and seizure of incriminating articles there is a strong reason to believe that the accused Pankaj Mahato (28) and Shiba Barman @ Bow (22) had carried the said fire arms and live ammunitions with an objective to commit heinous crime in the locality.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Pankaj Mahato (28) s/o Ram Chandra Mahato of Ratanlal Busty, Ward No. 07, PS Pradhna Nagar, Dist Darjeeling (ii) Shiba Barman @ Bow (22) s/o Dilip Barman of Durga Guri, Darjeeling More, PS Pradhan Nagar, Dist Darjeeling and arrange for its investigation.
