With due respect and humble submission, in producing herewith one accused namely Suraj Kamat (32) S/O Lt Satyan Kamat of Malhat W/No.1,P.O& P.S- Supaul,Dist.Supal ,Bihar under arrest along with following articles under proper seizure ;

- i) 45(Forty five ) Plastic bottles of TRIPLE EIGHT ,Blended Whiskey each bottle containing 180 ML
- ii) 25(Twenty-five) Pouch packet of Officer's choice ,Deluxe whisky ,each pouch containing 180 ml.

I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 23.06.22 myself along with force C/762 Mojibar Rahaman and CV/223 Swapan Chettri of PDN PS left for morning mobile duty Vide PDN PS GDE No.1410 dtd.23.06.22 at 08.10 hrs .During mobile duty at Siliguri Junction area at 08.25 hrs I received a source information that one Person moving at Siliguri Junction area with suspicious articles .Accordingly I inform to you and as per your order myself along with force arrived at Siliguri junction ,near Bihar Bus Stand and after reach the source identified him ,accordingly we are apprehend him and on interrogation he disclosed his name noted above ,on interrogation he stated that he carrying the liquor illegally for Bihar for sell the same for his wrongful gain .Accordingly I search his bag and recovered above noted articles , on demand he failed to produce any valid document in respect of recovered articles .I seized & label the above noted articles in between 08.45 hrs to 09.15 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Suraj Kamat (32) S/O Lt Satyan Kamat of Malhat W/No.1,P.O& P.S- Supaul,Dist.Supal ,Bihar and arrange for its investigation.
