I Shri Arbind Sha constitute Attorney of legal heirs of successors of Late Jatnu Ram namely Sri Vidyasagar Sha, Joginder Sha, Babua Sha, Yogesh Sha, Rabinder Sha all sons of Late Jatnu Ram Sha, resident of Gazipur, U.P. and Rina Devi, Meer Devi, Usha Devi daughters of Late Jatnu Ram Sha would like to inform you as follows:

One Subash Nath Sah Teli son of Late Kalika Prasad Teli and Surjanath Ram Teli was the owner of all that piece and parcel of land measuring about 1.34 acres recorded in Old Khatian no 2/1(old) new L.R. Khatian no 125, Plot number 375, 367 Paraga Pathargatha, Mouza Panchanoal, J. L. No 27 Police Station Pradhan nagar, Dist Darjeeling.

Subash Nath Sah Teli and Surjanath Ram Teli while being owner in possession of the suit transferred the same to the plaintiff and to one Mahati Prasad by a registered deed of sale dated 19/06/1967 registered in Book no I, Volume no 29, pages 179 to 181. Being number 3823 for the year 1967.

Since the date such purchase Late Jatnu Ram during his life time and the Mahati Prasad were enjoying the same jointly with any disturbances whatsoever from any quarter whatsoever as owners in possession of the said land.

Jatnu Ram became old and feeble and has reached the age of about 84 and as such he used to go and stay in his native place at District Gazipur and also come to visit his land whenever opportunity availed.

Taking advantage of the absence of Jatnu Ram, Surjanath Ram Teli created certain forged and fraudulent documents to a sham show of sale of lands belonging to Jatnu Ram Sha to and in favour of Suraj Nath Ram Teli. The said documents are out and out false and fictitious. After the death Suraj Nath Ram Teli his sons Lalji

Prasad Sha and Ashok Prasad Sha started selling lands to different persons. The said two persons have created false and fabricated documents and have sold the lands to One Sunil Agarwal son of Late Bhimraj Agarwal, Director of B.R. Real Estate (P) Ltd, 2nd Mile Bevoke Road, Billguri. The said sale deed was identified by one Jagan Yadav, son of Late Bholu Yadav, of Balbari.

All these persons named above together in collusion with each other had created false and fake documents to injure and demolish title of Jatnu Ram and his legal heirs.

Now one Naiti Agarwal and his brother Sri Sunil Agarwal both sons of Late Bhimraj Agarwal, resident of Resident of "Bhyama Kunj", Panjabpara, P.O. Bevoke Road, P.S. Bhaktinagar, Dist Jalpaiguri have started constructing buildings upon the said lands after purportedly purchasing the same from said Lalji Sha and Ashoke Sha, both sons of Late Surjyanath Prasad Sha, Resident of Balbari, P.O. Balbari, P.S. Pradhannagar, Dist Darjeeling.

Till today we have not got any justice and are being heckled and harassed by particularly by Naiti Agarwal and his brother Sri Sunil Agarwal both sons of Late Bhimraj Agarwal, resident of Resident of "Bhyama Kunj", Panjabpara, P.O. Bevoke Road, P.S. Bhaktinagar, Dist Jalpaiguri.

I therefore pray that your goodself may be pleased enough to initiate proper action against the said persons as per law.
