With due respect and humble submission, in producing herewith one accused namely Santosh Sah(34) S/O Rajendra Sah of Tea auction Road, Green Park, P.S-Pradhannagar, Dist. Darjeeling under arrest along with following articles under proper seizure ;

- i) **13(Thirteen) bottles of KINGFISHER, STRONG , PREMIUM BEER , each bottle containing 650 ML**
- ii) **12(Twelve) Plastic bottles of Himalayan Gold, Country Spirit, 60* up each bottle containing 600 ML**

I ASI Ashit Singha of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today night i.e on 25.06.22 at 01.16 hrs myself along with force CV/128 Ajay Kr Sahani , CV/223 Swapan Chettri all of Pradhannagar PS left for Night Patrolling duty at PS area ,Vide Pradhannagar PS GDE No.1518 dtd.25.06.22 and during night duty I received a source information that one person named Santosh Sah was storing and selling liquor illegally in his shop Styles as "Santosh Hotel"at Regulated market gate No.I under Pradhannagar PS .Accordingly I share the information with you , After rush to the spot and as pointed by the source we apprehended the above noted person and on search his shop ,recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for her illegal gain. Accordingly, I seized & label the above noted articles in between 01.25 hrs to 01.45 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Santosh Sah(34) S/O Rajendra Sah of Tea auction Road, Green Park, P.S-Pradhannagar, Dist. Darjeeling and arrange for its investigation.
