car, it stopped in front of me. The driver of the
Blue Maruti baleno bearing no OD02BL7672 came out
charging me with a khukri. ~~to~~ and I ran away to
save my life. Looking at my situation, locals people
came and catch hold of the attacker and thus
saved my life. I have never seen this man
nor do I know him before.
