Respected Sir,

I, Anil Roy, son of Late Kholakatu Roy, resident of Amtala Road, Chayan para, P.S. Bhaktinagar, District Jalpaiguri would like to state that my father Kholakatu Roy (during his life time), son of Late Jogeshwar Roy was the absolute owner in possession of land measuring 2 Bighas or 0.66 acres, comprised in L.R. Khatian no. 1816 arising from R.S. Khatian no. 291/10, appertaining to L.R. Plot nos, 262/729 and 728 arising out of R.S. Plot no. 154/182 of Mouza Dabgram, L.R. Sheet no. 4, R.S. Sheet no. 5, J.L. no. 2, Pargana Baikunthapur, P.S. Bhaktinagar, District Jalpaiguri (hereinafter referred to as the "said land/suit land"). After his demise, I along with other legal heirs of Late Kholakatu Roy namely Sri Samir Roy, Smt. Arati Roy, Smt. Jyotsna Roy, Smt. Sujita Roy, Sri Sajen Roy, Smt. Baneshwari Singha, Smt. Sumitra Roy and Smt. Sonika Roy became the owners in possession of the said land by virtue of inheritance as per the Hindu Succession Act.

For the last 1 year or so, one Sourav Garg and Ankush Goyal, Directors of Darjeeling Construction Pvt Ltd. having its office at Infinity Square, Sevoke Road, P.S. Bhaktinagar, District Jalpaiguri acting through their cronies and agent have been illegally trying to trespass into the aforesaid land against which we were constrained to file a suit in the Court of the Ld. Civil Judge, Junior Division at Jalpaiguri being Title Suit no. 67 of 2021 titled as Sri Anil Roy & Ors. Vs Darjeeling Construction Pvt. Ltd & Ors. wherein the Ld. Court vide its order dated 09.02.2021 was pleased to pass an order of injunction by way of status quo directing both the parties to the suit not to change the nature and character of the suit land till 09.03.2021 which is detailed above. The order of injunction has been extended by the Ld. Court on the relevant dates and lastly by the Ld. Court till 29.07.2022. (Copy of the order of the Ld. Court along with update information slip is annexed herewith for your perusal)

Despite the order of status quo issued by the Ld. Court, the aforesaid Sourav Goyal and Ankush Goyal on 21.06.2022 at around 2 p.m. accompanied with 4 unknown persons entered the land armed with bamboo poles and iron rods. They started hitting me and my family members with iron rods and bamboo poles due to which I sustained severe injury to my head and legs. Sourav Goyal and Ankush Goyal did not even spare the female members of my family and hit them with bamboo sticks. Sourav Goyal also



snatched the gold chain from my neck. Due to the sudden and severe attack by Sourav Goyel and Ankush Goyel and his men, I along with my family members started crying for help. Sourav Goyel and Ankush Goyel and his men, seeing the people of the locality coming for our help fled from the spot. Before leaving Sourav Goyel and Ankush Goyel declared that they would come again with more men and would oust us from the said land.

Sir I would like to say that Sourav Goyel and Ankush Goyel through their agents and muscle men have been trying to enter into the suit land in violation of the order of the Ld. Court and change the nature and character of the suit land in their favour and oust us from the said land. For the last one month or so, the illegal acts of Sourav Goyel and Ankush Goyel have become so persistent and grave that the law and order situation in the locality has become very critical. There is constant fear to our life and property and there is every possibility of the situation going out of hand.

In these circumstances, I would request you to kindly look into matter and protect my family and myself from the impending harm and ensure obedience of the orders of the Ld. Court.
