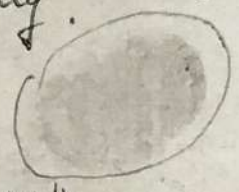
Dear Sir,

I am Gopa Chowdhury, my age is 33, my husband's name is Goutam Sarkar, I am writing this letter to report an FIR and accident that has happened to me on Sunday 19th June 2022 on ITI Road at 4.30 pm. I was returning to office after having lunch with my 5 years old son, Goutam Rishabh Sarkar, suddenly one particular man with his honda activa no: WB7140779, hit us with full speed, when I saw he was coming towards us I slowed down my Scooty (WB74BE9942) towards the end of the road, and I thought maybe he might stop it but still he hit us with full speed almost 90 km/h.

After he hit us, we got severely injured, my 5 years old son had 5 stitches in his head and his thumb was completely damaged, my hand got fractured and had plates in it right now.

We couldn't complain earlier because my husband was alone at that time and got busy with all the treatment.

This is my humble request to punish the guilty and do me justice.
