After that, when I click on it and fill it with my bank (UPI) information, After some time I notice that on message come to my phone (your VPA orjun9988 @ boi linked to my A/c no) After some time, I notice that RS 49,000, 48,000 and 2500 withdrawn from my account. I call back that number but didn't received and forward. That a fraud had been committed against me. So, I request you take strict action against this fraud that happen to me.
