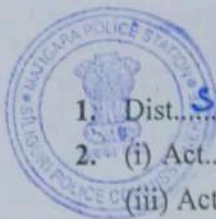

She physically assaulted me, scratched me which
resulted in ^{several} injury, I ~~to~~ was examined by the
doctor of Matigara Health Centre. I took
medicine and injection as prescribed by the doctor.

I was carrying my office bag in which I was
carrying valuables like purse, ATM, Voter Card,
Mobile phone. She, Ms. Arundhati Ghosh,
resident of Santiniketan, ^{Medical} Flat No. Block 10/5D

stopped the car of my colleague along with whom
I was travelling and about to reach office.
After that she assaulted me physically at
Gate No. 2, NBU and started to hit me,
scratched me, injured me. I started to bleed.

She ~~to~~ also snatched the bag with valuables.
She threw the bag ~~and~~ on the road.
I feel extremely humiliated and threatened.

I am scared to attend my regular duties
today onwards. Sirs, I humbly request you
to take necessary actions against her. I want
to inform you that if further this kind of

incidence takes place my dignity and respect
in university will be lost.

She, Ms. Arundhati Ghosh, also used
extremely filthy languages towards me.
I am really afraid to attend ^{my} office.
I am feeling insecure, as I predict
such kind of situation will reoccur.
~~Such~~ I beg your good self to take
immediate action since I predict ~~she~~,
Ms. Arundhati Ghosh, will again do
such criminal activities against me.

All the video footages of the incidence
is in my office watch and ward section.
You, Sir, can use it as a proof.
