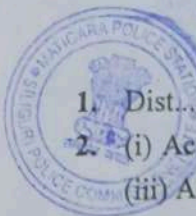

Sir,

With due respect I Miss Sabita Das, D/O Raj Kumar Das Das, Vill - Ram Krishna Jote, P.O. New Rangia, P.S. - Matigara, Dist - Darjeeling, Pin - 734010, do hereby want to inform you as follows :-

1. That in the month of January 2022 I joined the State Bank Of India as apprentice and was allotted to North Bengal Medical College (NBMC) branch on 03.01.2022 vide PF ID no. 8178674
2. That after joining in the said branch I noticed that the senior associate of the said branch namely Binoy Mukhia eventually started to show his good gesture towards me and being a senior colleague he always tried to come close to me by showing his helping nature. Subsequently he started to approach me to enter into love relationship with him and also started to allure me emotionally. After passing of some time he succeeded to convince me to enter into love relationship with him and I got serious emotional attachment with him, but he asked me to keep the relationship in secret for others and we will disclose the same in future.
3. That he always used to approached me for sexual talk over phone and whatsapp chatting from his phone number **7699990446** and **6294199055**. He used to send me nude pictures of him and also send me the link of porn websites and porn videos through whatsapp and when I used to feel uncomfortable in that situation he always try to convince me by saying that we are in love relationship and will marry each other in future so these gesture are very normal between us.
4. That when we used to meet in office everyday he always showed me sexual hint and when I used to work in the server room he come to that room and tried to touch my private parts by showing sexual gesture, as there is no cctv camera installed in the room he could do so easily. Whenever I tried to protest the same or hesitate to talk or chat sexual content with him he used to seduce me and allure me emotionally. The said Binoy Mukhia used to offer me money inside the office premise and out side also to impress me and gain my trust.

5. That the said Binoy Mukhia always tried to convince me to go with him to his house, but I never agreed at that time the said Binoy Mukhia used to take me to some public places and tried to touch the private parts of my body. Moreover he also used to tell me that he is the senior associate in the branch and if I get intimate with him then he will arrange for my permanent job with good post in the bank, but I never agreed to make physical relationship with him. The said Binoy Mukhia always used to show sexual content with me and also allured me to make sexual conversation with him. Moreover he also used to force me to come naked in front of live video call but I never agreed. It is to be mention here that the said Binoy Mukhia clicked some pictures of my private parts in his phone and he also used to share his nude pictures with me and always forced me to share my nude pictures with him over phone.
6. That subsequently I came to know that the said Binoy Mukhia has a girlfriend and he completely hide the matter from me. Subsequently after knowing the fact I tried to break all relation with him and told him not to keep contact with me anymore, but the said Binoy Mukhia started to force me to keep the said relationship with him and continued to send the sexual contents over phone and show his sexual gesture towards me. Subsequently when I protested the same and cut all the contacts with him he got furious and started to blackmail me by saying that if I do not continue the said relationship or refuse to get intimate with him then he will make viral of the pictures of my private parts and also destroy my social as well as professional carrier.
7. That at this when I tried to refuse to continue the said relationship with him and started to ignore him in the office then the said Binoy Mukhia started to make rumors about me in the office and showed the sexual content and chatting between us and also tried to destroy my social prestige to that extent so that I commit suicide. Moreover the said Binoy Mukhia along with some other staff started to taunt me in the office in illicit way and also abused me with filthiest languages and blackmailing me to that extentso that I became bound to get intimate with him.
8. That subsequently finding no other alternative in the month of April 2022 I communicated to the head office of the bank and described the matter through mail communication, but no action was taken against the said Binoy Mukhia, subsequently on 16.04.2022 I lodged written complaint

before the GARIMA committee R-II Siliguri, but no fruitful result come out.

9. That the said Binoy Mukhia blackmailed me and abused me so that I got emotionally and mentally depress to that extent that I commit suicide. The said Binoy Mukhia offered me money and also pressurized me not take any legal action against him.
10. That I am a lady comes from a respected family and my father has a social reputation in the said locality and the said Binoy Mukhia is trying to viral the said pictures of my private parts and he is also spreading rumors about me in the office to destroy my professional carrier resulting the destruction of my life and I have no other option to rather to end my life as my social prestige and dignity has been destroyed by the said Binoy Mukhia.
11. That the behavior of the said Binoy Mukhia towards meis totally harassive, malafide, breach of trust as well as cheating and exploit me sexually with an assurance to marry me.

Under the above mentioned situation I request you to kindly look after the above mentioned matter and take the necessary legal action as soon as possible to protect our life and dignity because at present I am living in a very dangerous situation as my prestige has already been destroyed by the acts of the said Binoy Mukhia.
