

Mr. Ashish Bhujel, s/o Kaval Bhujel, Sukantanagar, Upper Bagdogra, along with some miscreants and T.M.C goons, when I raised objection regarding fake voters and as such they chase me and he hit me with fist and blow and with dangerous weapons like iron rods as a result of fact I became blood injury and was unconscious for few minutes.

Thereafter my relatives taken me into Bagdogra Health centre for medical aid and proper treatment. It is further noted that they threatened me and my family members continuously with dire consequences.

Therefore, I would like to request you please take the appropriate steps against the below mentioned culprits and do the needful as you may deem fit and proper.
