FIRST INFORMATION REPORT (F.I.R.)

Respected Sir,

I, KUL PRASAD SHARMA, son of Om Prakash Sharma, R/o. Sukanta Nagar, Dara Gaon, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, INDIA, would like to state I am a candidate of Gram Panchayat Election from All India Trinamool Congress Party held on 26-06-2022 form Sukanta Nagar, Bagdogra area. Today at about 12.00 P.M. when I was at the election polling booth one person namely Siddhart Thapa, S/o. Budde Thapa R/o. Lalit Nagar, Vivekanandapally, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, INDIA, suddenly entered the election booth and tried to create a problem. He entered the polling booth and went near EVM machine with one Voter to caste vote. When I requested him not to create any problem inside the polling booth and requested him to go out of the Polling booth he attacked me and started physically assaulting me with hits and blow. Seeing this the peoples saved me from his cruel hands and with their help I anyhow managed to get rid of his hands. Due to his Physical assault I sustained injuries in my hand, head & chest. Thereafter my friends took me to Bagdogra PHC, RKS for treatment. Later I came to know that he is an election agent of BJP Panchayet Samity candidate. He threatened to murder me also.

He was using slang language at me and threatened me with dire consequences. Later after the elections were over when I was returning to my home Siddhart Thapa again chased me anti social elements. All of them were carrying sharp weapon. I was alone and became helpless and finding no other option I came before you. I am sure finding me alone Siddhart Thapa will again assault me.

It is requested before you in folded hand to kindly take strict necessary action against Siddhart Thapa.
