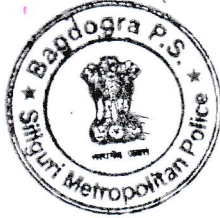


SUB:- HANDING OVER OF PASSENGER ALONG WITH ARMS (KATTA)

SIR,

On dated 26/06/2022 at about 14:30 hrs during screening of hand baggage of passenger from X-BIS No. 02 at Security Hold Area (SHA) by CISF No. 063610705 Rank SI/EXE Name Dilip Kumar Pandey noticed the image of arms (Katta) in the hand baggage of passenger namely Mr MD Rehanuddin, travelling by Flight No SG-322 Seat no 21F from Bagdogra to Chennai. Immediately bag was referred for physical check and opened under in the presence of passenger namely Mr. MD Rehanuddin under the custody of CISF No. 062302818 SI/Exe Ashish Kumar and recovered Arms (Katta). On interrogation, the passenger failed to produce valid license. Hence above pax handed over to you along with seized arms for further legal action under arms ACT 1959 and aircraft act 1934 and the rules framed there under.

02. Further, as per BCAS Avsec Circular No. 08/2017 and Avsec Order No. 02/2022 (Copy enclosed), above pax has violated the security norms.
