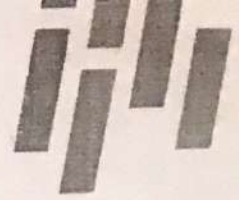

Our company is an outsourcing agency of WBSEDCL and is engaged for meter reading. An employee of our company who works as a meter reader under Power House CCC, residing at Sahani Busty, Prakash Nagar, Siliguri is missing from 20/06/2022. We have tried to reach him over the phone but his phone is switched off. We visited his house and informed his parents, but they are also not clearly informing us about his where about.

Since he works as a meter reader some equipment like Mobile phone, Bluetooth Printer and Charger are provided from the company to do the work. Every month from 20th onwards the meter reading of WBSEDCL starts and every reader is instructed to report to office from that day. However, when he did not report on 20/06/2022 we visited his house but could not find him. Later his parents told that he have gone out of station and will come by 21/06/22. Till date he has not returned and neither contacted us.

Therefore we request you to kindly lodge an FIR against him since the equipments are still in his possession and he is not returning back to the company. The official number provided with the mobile phone is 7483527324. We would request you to kindly take necessary action so that the company's equipments can be recovered as early as possible.
