Sir,

In producing herewith the seized 15 (Fifteen) bottles of "HIMALAYAN GOLD PREMIUM SPIRIT" each bottle containing 600 ML, MRP Rs.120/- (Total-9 Liter & Amount Rs 1800/-) and a written complaint against the lady accused person namely Smt Anju Das (45) W/O Late Dilip Das of Papiapara Naresh more PO Ghogomali PS Bhaktinagar Dist Jalpaiguri.

I SI Biswajit Biswas of Ashighar OP lodged a written complaint against the accused person Smt Anju Das (45) W/O Late Dilip Das of Papiapara Naresh more PO Ghogomali PS Bhaktinagar Dist Jalpaiguri to the effect that, today i.e 27.06.2022 evening as per order of O/C Ashighar OP I along with ASI Sumit Baran Nath C/877 Munna Ahmed, L/C 1234 Hira Roy and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no. 657 Dt 27.06.2022 in course of which I received information from my source that one Anju Das stored a huge numbers of bottles liquor inside her house at Papiapara Naresh more and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Papiapara Naresh more area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghugumali PS Bhaktinager Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjana Nagar W/no.36 PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Papiapara Naresh more area as indicated by my source I held raid at the house of Anju Das at Papiapara Naresh more. But the lady accused person managed to escape from the spot. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside her house. I seized the above noted articles as alammath of the case, as none could be able to produce any documents for such illegal possession of such articles. During enquiry I came to know the name and address of lady accused person is noted above. The Search and seizure were made in between 15.15 hrs and 15.35 hrs on 27.06.2022.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person Smt Anju Das (45) W/O Late Dilip Das of Papiapara Naresh more PO Ghogomali PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
