In producing herewith one accused person namely Shankar Das (27), S/O- Sri Jiten Das of Purba Majhabari PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

(1) 15 (Fifteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs 120/- (Total- 9 Liter & Amount Rs 1080/-)

1st Bhowraj Biswas of Ashghar OP PS Bhaktinagar lodged a written complaint against the accused person namely Shankar Das (27), S/O- Sri Jiten Das of Purba Majhabari PS Bhaktinagar Dist. Jalpaiguri to the effect that, today i.e. 27.06.2022 evening, as per order of O/C, Ashghar OP I along with ASI Sumit Baran Nath C/ 077 Munna Ahmed and CV/1016 Amrit Roy, all of Ashghar OP with Govt. vehicle no WB42/R-8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashghar OP as per order vide Ashghar OP GDE no. 657 Dt. 27.06.2022 in course of which I received information from my source that one Shankar Das stored a huge numbers of bottles of liquor inside his house at Purba Majhabari and used to sell to the local youth in higher rates. I immediately informed O/C Ashghar OP and as per his kind direction wasting no time I along with my accompanied party left for Purba Majhabari area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/O Kabi Charan Ghosh of Ghugumali PS Bhaktinagar Dist. Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjani nagar W/no. 36 PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Purba Majhabari area as indicated by my source I held raid at the house of Shankar Das at Purba Majhabari but seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alomath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of I.E Act. The Search and seizure and arrest were made in between 19.55 hrs and 20.15 hrs on 27.06.2022

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person Shankar Das (27), S/O- Sri Jiten Das of Purba Majhabari PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
