Sir,

In producing herewith the following accuseds namely (1) Badal Roy (20) S/O Sarath Roy of Purba Hatiadanga PS Bhaktinagar Dist. Jalpaiguri (2) Uttam Barman (19) S/O Dhiren Barman of do (3) Pulin Roy (18) S/O Kista Roy of do (4) Debasish Dey (28) S/O Late Sankar Dey of Madhya Shantinagar PS Bhaktinagar Dist Jalpaiguri and (5) Raj Roy (21) S/O Kajal Roy of Mahan Coloney Jaleshwari PS Bhaktinagar Dist. Jalpaiguri in custody along with the following seized articles:-

- i. One (1) Knife measuring about 11 inches in length made of iron including its wooden butt was recovered from the possession of accused Badal Roy (20) S/O Sarath Roy of Purba Hatiadanga PS Bhaktinagar Dist. Jalpaiguri
- ii. One (1) iron made Chopper measuring approx 16(Sixteen) inches length including handle recover from the possession of accused Uttam Barman (19) S/O Dhiren Barman. of Purba Hatiadanga PS Bhaktinagar Dist. Jalpaiguri
- iii. One (1) house breaking implement made of iron with pointed end measuring about 21" in length was recovered from the possession of accused Pulin Roy (18) S/O Kista Roy of Purba Hatiadanga PS Bhaktinagar Dist. Jalpaiguri
- iv. One (1) iron rod measuring about 3 feet in length was recovered from the possession of accused Debasish Dey (28) S/O Late Sankar Dey of Madhya Shantinagar PS Bhaktinagar Dist Jalpaiguri.

I, S.I Swapan Kr Ghosh of Ashighar OP P.S Bhaktinager would like to lodge this written complaint against the above noted accused persons and also 09/10 other unidentified persons to the effect that today i.e. on 28.06.2022 at about 00.05 hours received a secret source information that a group of 14-15 persons have assembled at Chota Fapri football ground near forest, under Bhaktinager P.S, Dist-Jalpaiguri with deadly weapons with a view to commit some heinous crime. Accordingly without wasting any time I informed the matter to O/C Ashighar OP and diarised the whole fact in Ashighar OP GDE No. 676 Dated 28.06.2022, Then at 00.10 hrs, as per instruction of O.C Ashighar OP I along with ASI Ujjal Mandal, ASI Amit Mallick, C/877 Munna Ahmed, CV/1016 Amrit Roy all of Ashighar OP left for spot to verify the veracity of the information and to work upon it, noted in Ashighar OP GDE NO. 677 Dt- 28.06.2022. We reached near the spot as directed by the source at about 00.35 hours and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement. On way we meet two respectable persons of the locality namely (1) Sujit Roy (31) S/O Late Satish Roy of Naresh More Telipara PS Bhaktinager dist. Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjana Nagar w/no. 36 PS Bhaktinagar Dist. Jalpaiguri and to whom we disclosed our motto and identity and asked them to accompany us if any search and seizure is necessary for the purpose and they agreed. We reached at Chota Fapri football ground near forest, at about 00.50 hrs and found a group of 14/15 persons sitting at Chota Fapri football ground near forest. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 05 above referred accused persons. After

Apprehension the 05 persons disclosed their identity as noted above and also stated that there were 09/10 other persons with them and they were planning to commit a dacoity on the house of a businessman at Baneshwar More area. Thereafter all the apprehended persons were searched in presence of the witnesses and the following articles were seized as follows:-

- v. One (1) Knife measuring about 11 inches in length made of iron including its wooden butt was recovered from the possession of accused Badal Roy (20) S/O Sarath Roy of Purba Hatiadanga PS Bhaktinagar Dist. Jalpaiguri
- vi. One (1) iron made Chopper measuring approx 16(Sixteen) inches length including handle recover from the possession of accused Uttam Barman (19) S/O Dhiren Barman. of Purba Hatiadanga PS Bhaktinagar Dist. Jalpaiguri
- vii. One (1) house breaking implement made of iron with pointed end measuring about 21" in length was recovered from the possession of accused Pulin Roy (18) S/O Kista Roy. of Purba Hatiadanga PS Bhaktinagar Dist. Jalpaiguri
- viii. One (1) iron rod measuring about 3 feet in length was recovered from the possession of accused Debasish Dey (28) S/O Late Sankar Dey of Madhya Shantinagar PS Bhaktinagar Dist Jalpaiguri.

Thereafter all the articles were seized in-between 01.15 hrs to 01.35 hrs. Issuing a proper seizure list duly signed by the witnesses and the accused persons. Thereafter all the persons were arrested after observing all formalities of arrest as they are assembled for committing heinous crime.

On the above circumstances, I pray before you that a specific case may kindly be started against the 05 arrested accused persons namely (1) Badal Roy (20) S/O Sarath Roy of Purba Hatiadanga PS Bhaktinagar Dist. Jalpaiguri (2) Uttam Barman (19) S/O Dhiren Barman of do (3) Pulin Roy (18) S/O Kista Roy of do (4) Debasish Dey (28) S/O Late Sankar Dey of Madhya Shantinagar PS Bhaktinagar Dist Jalpaiguri and (5) Raj Roy (21) Kajal Roy of Mahan Coloney Jaleshwari PS Bhaktinagar Dist. Jalpaiguri and 09/10 others unidentified persons for such assemble with deadly weapons and arrange for its investigation.
