In producing herewith one accused person named Rakesh Paul (40) S/O Lt. Umesh Paul, of Santi Kuthi Club, Khagrabari PS- Kotwali Dist- Coochbehar, along with the following seized articles :-

1. 25 (twenty five) bottles of TUBORG PREMIMUM STRONG BEER each bottle containing 650 ml. manufactured by Carlsberg India Pvt.Ltd.


I, SI Sibdhan Karmakar of Pradhannagar P.S under Siliguri Police Commissionerate do here by lodged a written complaint against Rakesh Paul (40) S/O Lt. Umesh Paul, of Santi Kuthi Club, Khagrabari PS- Kotwali Dist- Coochbehar, to the effect that on 27/06/2022 at 21 :55 hrs. Received a specific input from the source that the above noted person has kept huge numbers of illicit liquor in his shop at Uttar Mallguri in his Shop in order to clandestinely dispose the same. Accordingly the fact is informed to you and as per your kind direction myself along with ASI Tarun kanti Ghosh, ASI Asit Singha, CV 223 Swapan Chettri left for Uttar Mallguri under Pradhannagar PS to verify the veracity of the information. This refers to Pradhannagar P.S. G.D.E. No- 1669 date 27/06/2022. On reaching there and as identified by source cordoned the shop where he kept illegal alcohol. On arriving there found the above noted person who disclosed his identity as noted above who kept the same at his shop in conceal position. On searching found 25 (twenty five) bottles of TUBORG PREMIMUM STRONG BEER each bottle containing 650 ml. manufactured by Carlsberg India Pvt.Ltd. On being interrogation he could not produce any valid documents in respect of the said illicit liquor. He also stated that he is doing this liquor business since last 05 months for his wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 22:35 hrs to 22:55 hrs. On being asked he stated that he kept the same with a view to sale and supply at Mallaguri area without any valid documents. As he has violated the rules and norms of Bengal Excise Act as such I arrested him after observing all sorts' rules for selling the said illegal beer without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Rakesh Paul (40) S/O Lt. Umesh Paul, of Santi Kuthi Club, Khagrabari PS- Kotwali Dist- Coochbeharb, as per proper section of law.


