- i) **12(Twelve) Plastic bottles of Himalayan Gold, Country Spirit, 60* up each bottle containing 600 ML**

I SI Sibdhan Karmakar of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today i.e on 28.06.22 myself along with force CV/992 Jagadish Biswas, CV/223 Swapan Chettri all of Pradhannagar PS left for evening Patrolling duty at PS area ,Vide Pradhannagar PS GDE No.1726 dtd.28.06.22 and during patrolling duty I received a source information that one person named Madan Majumder was storing and selling liquor illegally in hotel Styles as "Narayan Hotel"at Regulated market gate No.I under Pradhannagar PS .Accordingly I share the information with you ,and as per your direction After rush to the spot and as pointed by the source we apprehended the above noted person and on search his shop ,recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for her illegal gain. Accordingly, I seized & label the above noted articles in between 19.25 hrs to 19.55 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Madan Majumder(50) s/O Lt. Rajendra Lal Majumder C/O Ram Narayan Ram Regulated market gate No.1 ,P.S-Pradhannagar, Dist.Darjeeling and arrange for its investigation.
