Sub- FIR against Avijit Roy

Respected Sir,

I am Sujata Maity, wife of late Dr Ajit Kumar Maity, resident of E.K.T.P Phase II, Abhyuday Housing, Flat B 11/14, Kolkata - 700107.

I had purchased a land measuring 8 katha of Mouza Thikaitaha, P.S. Maligara, pertaining to PS plot No 1 and corresponding to part of LR Plot No 1 by two separate sale deeds bearing nos 4608/2000, and 4607/2000. Khata No - 1035.

I have been possessing this land peacefully since the date of purchase. The land was subsequently converted from Rupni to Basti on 27.07.18

After my husband's demise, I moved to Kolkata. During the time of lockdown I have not been able to visit my land.

On 25.05.2022 I went to my land and Avijit Roy son of late Amol Roy, resident of Thikaitaha, P.O. - Sushrutanagar, P.S. Maligara, Dist. - Darjeeling restrained me from entering my own land.

I lodged an FIR in Maligara, P.S. Case No 614/2022 dated 25.05.2022 under section 341/506/463/464/471/34 of the IPC. He was in police lock up for 3 days and is out on interim bail.

On 27.06.2022 when I went to visit my land Avijit Roy had locked my gate with two locks from inside. I broke these two locks and Avijit started abusing me with the most filthy language.

Today i.e. 28.06.2022 Avijit Roy along with 16 persons came to demolish the boundary made of brick which was set up by me. While the miscreants were carrying out their heinous activities, my men chased them and apprehended two persons.

The two miscreants apprehended by my men have clearly stated that they have been employed by Avijit Roy and Santosh Roy resident of the wall adjacent to North Bengal Medical College.

So Avijit Roy has also stolen the wooden board on which the electric connection was to be installed. He has stolen tin panels, Iron pipes, electric board, and TMT Iron rods which was to be used for building construction. I have incurred huge loss of money.

Avijit Roy who is out on bail is violating peace and order. He is employing men against me for harmful activities.




In view of this, I plead with folded hand to take necessary action against Avijit Roy
