
I, PSI Shekhar Adhikary of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person named Kanu Barman(34), S/O- Lt. Harkumar Barman of Kala Bagan, Patiramjote, PO+PS- Matigara, Dist.- Darjeeling to the effect that on 28.06.2022 at 23.05 hrs received a source information that one person named Kanu Barman(34), S/O- Lt. Harkumar Barman of Kala Bagan, Patiramjote, PO+PS- Matigara, Dist.- Darjeeling is selling liquor in his tea stall at Kalabagan under PS - Matigara, Dist.- Darjeeling without any valid license. Accordingly the fact is diarized in General Diary vide Matigara PS GDE No 1491 Dated 28.06.2022 and shared the information with O/C Matigara PS and as per his kind direction myself along with force had been to Kalabagan under PS - Matigara, Dist.- Darjeeling to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the tea stall of the above noted accused named Kanu Barman and managed to apprehended him. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor at his tea stall without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from the said Tea Stall of Kanu Barman. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Kanu Barman(34), S/O- Lt. Harkumar Barman of Kala Bagan, Patiramjote, PO+PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 29.06.2022 in between 00.05 hrs to 00.35 hrs.


