With due respect I, **SMT. SHANTI DAS**, W/O Sri Naba Kumar Das, resident of, C/o Manik Ghosh, Anandamayee Kalibari Road, Near Bhai Bhai Club, Ward No. 40 (S.M.C.), P.O. Haider para, P.S Bhaktinagar, District Jalpaiguri, would like to lodge a Written Compliant before your good office to the effect that on 26.06.2022 at about 10:00 P.M. at night when my husband was returning to our house from market at that point of time one person namely Raju Das, son of Late Kanu Das, residing at C/o, Dhiren Das of Anandamayee Kalibari Road, Near Bhai Bhai Club, Ward No. 40 (S.M.C.), P.O. Haider para, P.S Bhaktinagar, District Jalpaiguri started to abuse my husband with abusive and filthy languages and when my husband raised objection of his such acts the above named Raju Das started to assault my husband with fists and blows and suddenly he took a brick and attacked on the forehead of my husband as a result my husband sustained severe grievous injury on his forehead and as well as on different body parts and my husband fall down on the road. Moreover, the above named person forcefully entered into my room and touched my private parts and tried to

outrage my modesty and when I raised objection of his such acts he assaulted me as well and he taken away a cash of Rupees 1800/- from my room and snatched a silver chain from my neck and while going outside he also assaulted my son along with his wife namely Smt. Maya Das and when I started hue and cry, some local people gathered there and seeing the said situation, said Sri Raju Das and his wife fled away from the spot. After the said incident I took my husband to Siliguri District Hospital, and due to the said incident, I became mentally depressed and my husband got severe injuries on his body and at the time of leaving the spot, said Raju Das also threatened me not to inform the said facts to any authority, otherwise he will not hesitate to kill my entire family.

I, therefore, request you to investigate the matter and please take necessary legal steps against said Raju Das and Maya Das as per the provision of law and obliged thereby.
