Sir,

I, PSI Rantu Haldar of Bhaktinagar PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against one Samir Mitra (57 yrs) S/o Lt. Ajit Mitra of Haydarpara, W/No. 39, PS-Bhaktinagar, Dist. Jalpaiguri under arrest along with following seized articles:-

1. 18 (Eighteen) Bottles of Himalayan Gold Country Spirit 60 UP each bottle containing 600 ml

I, PSI Rantu Haldar of Bhakti Nagar PS, Siliguri Police Commissionerate beg to report that today on 28/06/22 at about 19.25 hrs. I along with force was engaged on mobile van duty at PS area and received information that one person who carrying huge illicit liquor near Ghugni more under Bhakti Nagar PS for selling to the local customers for illegal gain. This refers to Bhakti Nagar PS GDE No. 1433 dt. 28/06/22. As soon as after receiving the information I informed the matter to I/C Bhaktinagar PS and as per his kind order and instruction I conducted raid near Ghugni More under Bhakti Nagar PS and apprehended one person namely Samir Mitra (57 yrs) S/o Lt. Ajit Mitra of Haydarpara, W/No. 39, PS- Bhaktinagar, Dist. Jalpaiguri and seized the above noted articles from his possession. During raid I found that the above noted arrested accused possesses the above noted articles for selling it to the local customers since long for wrongful gain. Accordingly, I seized the above noted articles in presence of witnesses. I demanded him the papers or license, cash memo of the said liquor but he failed to produce any documents in support of possession of above noted illicit liquor. On interrogation, he disclosed his name as mentioned above and admitted that he procured the liquor illegally and selling the same illegally to the people. Accordingly, I seized the same after preparing proper seizure list duly signed by the witnesses. The articles were seized in between 19.50 hrs to 20.20 hrs. and accused, Then, I arrested him U/S 41 Cr.P.C.

Therefore I pray before your honour that a specific case may kindly be started against accused namely Samir Mitra (57 yrs) S/o Lt. Ajit Mitra of Haydarpara, W/No. 39, PS-Bhaktinagar, Dist. Jalpaiguri as per proper section of law.
