Sir,

In producing here with the one arrested accused person namely Narayan Sarkar 29 yrs S/o Mahendra Sarkar of Tikiapara 01- no Matangini Hazra colony, ward no 28, PS- Siliguri Dist- Darjeeling along with the following seized articles as per proper seizure list:

1. Twenty (20) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 20 = Rs- 2400)

I SI Basudev Guha of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Narayan Sarkar 29 yrs S/o Mahendra Sarkar of Tikiapara 01- no Matangini Hazra colony, ward no 28, PS- Siliguri Dist- Darjeeling to the effect that on 27/06/2022 at about 16.15 hrs (vide Siliguri PS GDE no- 1552 dt- 27/06/2022) I received a source information from Tikiapara, 01 no Matangini Hazra colony w/no-28 that one person namely Narayan Sarkar he selling huge quantity of liquor illegally at Tikiapara ward no 28 in his hotel to his design customers since long, for his wrongful gain. about the information shared with I/C, Siliguri P.S. and as per his kind instruction myself along with my accompanied officers and force, ASI Siben Sarkar, ASI Debasis Das, CV/ Prosenjit Dey, CV/ Ramanath Barman proceeded to the Tikiapara to work out the source information (vide Siliguri PS GDE no 1553 dt- 27/06/2022), at about 16.50 hrs I along with my accompanied officers and force reached at Tikiapara Matangini- 01, ward no 28 and, on being identified by the source our police team held raid in the hotel of Narayan Sarkar and managed to apprehended him and recovered Twenty (20) bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml, which is concealed inside of the kitchen. On interrogation he disclosed his identification as Narayan Sarkar 29 yrs S/o Mahendra Sarkar of Tikiapara 01- no Matangini Hazra colony, ward no 28, PS- Siliguri Dist- Darjeeling and he admitted that he sell the same to his design customers from since long for his wrongful gain. On demand he failed to produce any valid documents or licence in r/o said liquor, accordingly I seized the same viz; 1. Twenty (20) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml (Total market value RS/- 120 X 20 = RS/- 2400) from the possession of Narayan Sarkar 29 yrs S/o Mahendra Sarkar of Tikiapara 01- no Matangini Hazra colony, ward no 28, PS- Siliguri Dist- Darjeeling (**seizure and labelled was made between 17.05 hrs to 17.45 hrs**) in presence of witnesses duly sign by the accused as well as witnesses. As he violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 41 Cr.P.C appraise him the ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested person namely Narayan Sarkar 29 yrs S/o Mahendra Sarkar of Tikiapara 01- no Matangini Hazra colony, ward no 28, PS- Siliguri Dist- Darjeeling under proper section of law.
