Punjabi Para Ward No. 13, P.S. Siliguri, Dt. Darjeeling
would like to inform that yesterday 26/6/2022 at
around 3.30 PM my son Keshav Agarwal met
with an accident near Lakimpura, T.S. Club
while riding on a Scooty No. WB74BE9553
while coming back home. A pickup vehicle
No. WB73A9239 banged the above scooty
No. WB74BE9553 head on due to which
the scooty skidded and my son was
thrown inside the roadside drain, causing
serious injury to my son. As soon as we
received message of his accident we rushed
him to the emergency ward of Shanti
Nursing Home, near panitanki more. As he
is seriously injured he is admitted in
ICU with serious injuries and fractures.

Kindly request you to look into the
matter so that justice is provided to us.
