Dukha Singh, my mother-in-law namely (2) Smt. Kiran Debi Singh W/O Sri Sateb Singh, my brother-in-law namely (3) Rajib Singh S/O Sri Sateb Singh & (4) my sister-in-law namely, Smt. Kajal Singh W/O Sri Rajib Singh, all of above noted address, started abusing me on filthy language & when my said husband, protested, they attacked on him with iron rod, and also beaten brutally my daughter namely (1) Sanakesh Singh (9 yrs) & (2) Aarohi Singh (18 months) and threatened that they will engage other persons to rape me and murder me and hide out my dead body
