In producing herewith two arrested accused persons namely (1) Md Rafique (28) S/O Md Nirshu address Tumbajote Dangibusty PS Matigara Dist. Darjeeling (Driver of Vehicle No. WB-78-4448) and (2) Md Salim (23) S/O Md Nirshu address Tumbajote Dangibusty PS Matigara Dist. Darjeeling (Driver of Vehicle No. WB-76-B- 1488) under proper Memo of Arrest along with seized articles and the copy of seizure list viz.

1. One PICK VAN having Registration No. WB-78-4448.

2. 06 (six) numbers in which 03 cows and 03 calves in different colour and sized which carrying in the Vehicle bearing No. WB-78- 4448.

3. One PICK VAN having Registration No. WB-76-B- 1488

4. 06 (six) numbers in which 03 cows and 03 calves in different colour and sized which carrying in the Vehicle bearing No. WB-76-B- 1488.

I ASI Khagen Barman of Bagdogra P.S, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted arrested accused persons to the effect that on 29.06.22 at about 12-15 hrs received a secret source information that two PICK UP VAN are being loaded cows towards Siliguri side without any valid illegally and coming from the Naxalbari side documents/papers and if immediate action is taken, it can be apprehend at Bagdogra Bihar More. Accordingly, I share the information with O/C Bagdogra P.S and as per his direction myself along with C/1008 Kanak Roy, CV/389 Janak Singha, CV-386 Kishor Ranjan Howlader, VP-02 Pradip Roy, VP-01 Anselam kujur left for Bagdogra Bihar More to verify the veracity of information vide Bagdogra PS, GDE no 1391 dt. 29.06.22. At about 12-35 hrs we reached at Bagdogra Bihar more and on identified by the source we intercepted the said two vehicle and apprehended the drivers of the said vehicles. During search it is found that the vehicle bearing No. WB-78- 4448 was loaded with 06 (six) numbers in which 03 cows and 03 calves in different colour and sized illegally and vehicle bearing No. WB-76-B- 1488 was loaded with 06 (six) numbers in which 03 cows and 03 calves in different colour and sized illegally. On being asked the both driver of the said vehicles disclosed their name and address mentioned above and also stated that the cows were carrying those cows in their vehicle from Naxalbari towards to Fulbari side ,Jalpaiguri for sale illegally. On asked, they failed to produce any valid License/ papers in support of carrying the said cows in that vehicles and also failed to produce any papers in respect of the said cows and calves . It is suspected that the recovered cows and calves were stolen from anywhere. On further checking it was found that there was no arrangement made for food and water for the said cows and calves as per Govt. rules. Besides this there was no sufficient space for the Cows in those vehicles. The apprehended both drivers of vehicle also failed to produce any papers/documents in support of the said vehicles. Accordingly I seized the (1) 06 (six) numbers in which 03 cows and 03 calves in different colour which loaded in Vehicle No. WB-78-4448 (2) 06 (six) numbers in which 03 cows and 03 calves in different colour which loaded in Vehicle No. WB-76-B- 1488 and also seized the both Vehicle bearing No WB-78- 4448 and WB-76-B-1488 under proper seizure list and arrested both accused drivers U/S 41 Cr P.C , informing him the grounds of their arrest as they are violation of The Prevention of Cruelty to Animals Act 1960. The seizure and arrest have been made in between 12-45 hrs to 01.35 hrs.
