Respected Sir,

In producing herewith one arrested accused person namely Lal Mohan Jha (M/55), s/o Lt Radhakant Jha of Village-Gopal Pore, PO-Gopal Pore and Chapram Kothi, PS- Simri Baktiarpur, Dist- Saharsha , Bihar At Present Rented House C/O Bablu Saha of Raja Ram Mohan Roy Road, Near Krishna Maya Nepali School, w/n- 12, PS-Siliguri, Dist- Darjeeling along with seized articles:-

1. 10 (Ten) Bottles Country Spirit styled as 60 UP PET Himalayan Gold of 600 ml Each, MRP Rs. 120/-
2. 09 (Nine) Bottles Country Spirit styled as 60 UP PET Himalayan Gold of 300 ml Each, MRP Rs. 50/-
3. 01(One) Nylon Bag which used for carrying the seized articles SL. No. 1 and 2

I, ASI Mantu Dey of Panitanki TOP under Siliguri PS/SPC herby lodge a written complaint against the above noted accused person to the effect that today i.e. on 27.06.2022 in course of my Night Mobile van duty I received one secret source information to the effect that one person is carrying huge quantity of bottled country spirit through Mahakal Pally towards Erview More, Siliguri. Accordingly the information shared to O/C, Panitanki TOP and thereafter as per his direction I along with, Const/576 Binoy Chandra Roy, CV-1007 Jiten Roy arrived at Mahakal Pally , Siliguri at 00.15 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of available witnesses. During interrogation the accused failed to produce any documents/license in support of the same and stated that he sale the same to the local public at Mahakal Pally adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized (1) 10 (Ten) Bottles Country Spirit styled as 60 UP PET Himalayan Gold of 600 ml each, MRP Rs.120/- and 2) 09 (Nine) Bottles Country Spirit styled as 60 UP PET Himalayan Gold of 300 ml each, MRP Rs.50/- and 3) One Nylon Bag which used for carrying the seized articles SL. No. 1 and 2 under proper seizure list and labelled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made between 00.35 hrs to 01.15 hrs. Then I arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. The local public was also annoyed with him because of his this kind of illegal activities. As such there was no scope to serve Notice u/s 41A of Cr.P.C.

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Lal Mohan Jha (M/55), s/o Lt Radhakant Jha of Village-Gopal Pore, PO-Gopal Pore and Chapram Kothi, PS- Simri Baktiarpur, Dist- Saharsha , Bihar At Present Rented House C/O Bablu Saha of Raja Ram Mohan Roy Road, Near Krishna Maya Nepali School, w/n- 12, PS-Siliguri, Dist- Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
