Sir,

In producing herewith two (02) arrested accused persons namely (1) Dilip Sarkar @ Dilu (47), S/O- Sri Dinesh Sarkar of Rathkhola, Subhash Nagar Colony, W/No - 22, PS. Siliguri, Dist. Darjeeling and (2) Nemai Dhar (54) @ Nilu, S/O- Lt. Nira Pada Dhar of Sarbohara Colony, W/No - 28, PS. Siliguri, Dist. Darjeeling, A/P Bidhanpally, Kowakhali, PS. Matigara, Dist. Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron claw bar measuring 17 inch (approx), from the possession of Dilip Sarkar which was kept concealed on his back side,
- (2) One iron claw hammer measuring 17 inch (approx), from the possession of Nemai Dhar which was carrying on his right hand,

I, ASI- Siben Sarkar S/O Lt. Raghupada Sarkar of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others viz. Jiten Barai, Gaurango, Toton, Bappa, Binod and others to the effect that today on 28.06.2022 at 00.15 hrs received a sources information that 13/14 youths have assembled at Vivekananda road near Railway Track with a view to commit dacoity in a house at Khalpara area. The fact was diarized in GD vide Siliguri PS GDE No- 1579 dated 28.06.2022. Subsequently after sharing the information with I/C Siliguri PS and as per his direction, myself along with ASI- Rabin Lama, ASI- Debasish Das, CV/622 Ramanath Barman and CV/283 Prasenjit Dey, left for the place to work out the information. On way I contact ASI Srijit Paul who was performing k-21 Van to accompany us to workout the information. We reached at Vivekananda Road near Railway Track at 00.35 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from Vivekananda Road near Railway Track and seeing police personnel they tried to flee away from the spot but on hot chase we managed to apprehend above noted three (03) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused person admitted that they had assembled there to commit dacoity in a house at Khalpara area with the leadership of Jiten Barai and Gaurango.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused person. The whole seizure was made in between 01.10 hrs to 01.45 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Khalpara area. It is also revealed from them that (1) Jiten Barai, (2) Gaurango (3) Toton(4) Bappa (5) Binod and some others have been assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Dilip Sarkar @ Dilu (47), S/O- Sri Dinesh Sarkar of Rathkhola, Subhash Nagar Colony, W/No - 22, PS. Siliguri, Dist. Darjeeling and (2) Nema Dhar (54) & Nilu, S/O- Lt. Nira Pada Dhar of Sarbohara Colony, W/No - 28, PS. Siliguri, Dist. Darjeeling, A/P Bidhanpally, Kowakhali, PS. Matigara, Dist. Darjeeling, (3) Jiten Barai, (4) Gaurango (5) Toton(6) Bappa (7) Binod and others and arrange for its investigation.
