Sir,

In producing here with the one arrested accused Ramnath Paswan (45) S/O late Sudama Paswan of Sarbahara Colony, ward no 28 PS- Siliguri Dist- Darjeeling along with Fifteen (15) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 15 = Rs1800/-)

I ASI Debasish Das of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Ramnath Paswan (45) S/O late Sudama Paswan of Sarbahara Colony, ward no 28 PS- Siliguri Dist- Darjeeling to the effect that on 29/06/2022 during my mobile van duty (vide Siliguri PS GDE no 1683 dated 29/06/2022) I received a source information at about 15.25 hrs from Sarbahara colony, ward no 28 under Siliguri PS, that one Ramnath Paswan of Sarbahara colony, Chittaranjan road, ward no 28 is selling huge quantity of liquor illegally in his house to his design customers since long, for his wrongful gain. After sharing the information with I/C Siliguri and as per his kind direction, I along with ASI Siben Sarkar, ASI Rabin Lama, CV/263 Prasenjit Dey proceeded to the P.O to work out the source information. At about 15.55 hrs I along with my police team reached Sarbahara colony, Chittaranjan road ward no 28, on being identified by the source our police team held raid in the house of Ramnath Paswan and managed to apprehended the said person, and recovered Fifteen (15) bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml. from his house. On interrogation he disclosed her identification as Ramnath Paswan (45 yrs) S/O late Sudama Paswan of Sarbahara Colony, ward no 28 PS- Siliguri Dist- Darjeeling and admitted that he sell the same to his design customers since long for his wrongful gain. On demand he failed to produce any valid documents or licence in r/o said liquor. accordingly I seized the same viz: Fifteen (15) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 15 = Rs1800/-) from the possession of Ramnath Paswan (45) S/O late Sudama Paswan of Sarbahara Colony, ward no 28 PS- Siliguri Dist- Darjeeling (seizure and labelled was made between 16.05 hrs to 16.40 hrs) in presence of witnesses duly sign by the accused as well as witnesses. As he violated the rules and norms of Bengal Excise Act. as such I arrested him u/s 41 Cr.P.C appraise him ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested Ramnath Paswan (45) S/O late Sudama Paswan of Sarbahara Colony, ward no 28 PS- Siliguri Dist- Darjeeling under proper section of law.
