In producing here with the one arrested accused Dipak Biswas (47 yrs) s/o- late Asutosh Biswas of Sarbahara Colony. Chittaranjan road, ward no 28 PS- Siliguri Dist- Darjeeling along with Sixteen (16) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 16 = Rs1920/-)

I ASI Siben Sarkar of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Dipak Biswas (47 yrs) s/o- late Asutosh Biswas of Sarbahara Colony, Chittaranjan colony ward no 28 PS- Siliguri Dist- Darjeeling to the effect that or 09/06/2022 during my mobile van duty (vide Siliguri PS GDE no 1683 dated 29/06/2022) I received a source information at about 17.15 hrs from Sarbahara colony, ward no 28 under Siliguri PS, that one Dipak Biswas of Sarbahara colony, Chittaranjan road, ward no 28 is selling huge quantity of liquor illegally in his house to his design customers since long, for his wrongful gain. After sharing the information with me I/C Siliguri and as per his kind direction, I along with ASI Debasis Das. ASI Rabin Lama CV/263 Prasenjit Dey proceeded to the P.O to work out the source information. At about 17.25 hrs I along with my police team reached Sarbahara colony, Chittaranjan road ward no 28, on being identified by the source our police team held raid in the house of Dipak Biswas and managed to apprehended the said person, and recovered Sixteen (16) bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml. which was laying under the bed. On interrogation he disclosed her identification as Dipak Biswa (47 yrs) s/o- late Asutosh Biswas of Sarbahara Colony, Chittaranjan road, ward no 28 PS- Siliguri Dist Darjeeling and he admitted that he sell the same to his design customers since long for his wrongful gair On demand he failed to produce any valid documents or licence in r/o said liquor, accordingly I seized th same viz; Sixteen (16) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml (Tota market value RS/- 120 X 16 = Rs1920/-) from the possession of Dipak Biswas (47 yrs) s/o- late Asutos Biswas of Sarbahara Colony, Chittaranjan road, ward no 28 PS- Siliguri Dist- Darjeeling (seizure an labelled was made between 17.40 hrs to 18.15 hrs) in presence of witnesses duly sign by the accused a well as witnesses. As he violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 4 Cr.P.C appraise him ground of arrest and issued arrest memo in presence of witnesses.
