Sir,

In producing herewith one arrested person namely Sushil Mandal (57/M)S/O laye Sitaram mandal of Santoshinagar, Near Ramjanki Mandir, ward no-05, PS- Siliguri, Dist- Darjeeling along with 15 (fifteen) bottles of Himalaya Gold 60up Country spirit each bottles containing 600 ML. & MRP Rs 120/- each bottle Total RS. 1800/- Only. (one thousand eight hundred)

I ASI Sanjay Hasda of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that on 29.06.2022 while my performing K-27 evening van duty at 18.40 hrs received an information that one person has gather the huge quantity of illegal liquor which was kept in his house at Santoshinagar, Near Ramjanki Mandir for his wrong full gain. Diarized the fact in GD vide Khalpara TOP GDE NO – 726 Dated- 29.06.2022. As per information I inform to O/C Khalpara TOP under Siliguri PS and as per his kind direction myself along with force proceeded to the PO to work out the information. At 19.25 hrs. we reached at Santoshinagar, Near Ramjanki Mandir, ward No- 05 PS- Siliguri, Dist- Darjeeling some times after being identified by the source our police party held raid and recovered the above noted articles from the possession of above referred person. On demand he could not produced any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in open marked for his wrong full gain. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizer list and with level and took signature of the accused person on one bottles taken as sample. The seizure was made in between 19.45hrs to 20.25hrs. I arrested the accused person U/S 41 Cr. P.C and issued Memo of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Sushil Mandal (57/M)S/O laye Sitaram mandal of Santoshinagar, Near Ramjanki Mandir, ward no-05, PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for investigation .
