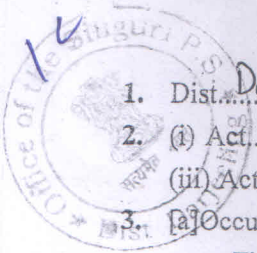

Respected Sir,

In producing herewith one arrested accused person namely Sujon Mardi (M/20), S/O Sri Joseph Mardi of Village Kolohori, Balurghat, PO-Chand Ganj, PS-Kumar Ganj, Dist- Dakhin Dinajpur A/P Shib Nagar near Gass Godown, Darjeeling More, PS-Matigara, Dist- Darjeeling along with seized articles:-

1. One (01) Shield Bottle 'TUBROG' Premium Beer Strong of 650 ML, Manufactured by Carlsberg India Pvt. Ltd, MRP Rs/- 120/-
2. Two (02) Shield Bottle 'KINGFISHER' Strong Beer of 650 ML each, Brewed & Bottled by United Breweries, MRP Rs/- 120/-
3. Five(05) Bottles Country Spirit styled as 60 UP PET "HIMALAYAN GOLD" of 600 ml each, MRP Rs. 120/-
4. Three(03) Bottles Country Spirit styled as 80 UP PET "HIMALAYAN TUK " of 600 ml each, MRP Rs. 55/-
5. 01(One) Nylon Bag which used for carrying the seized articles SL. No. 1 to 4

I, ASI Gopesh Chandra Barman of Panitanki TOP under Siliguri PS/SPC herby lodge a written complaint against the above noted accused person to the effect that today i.e. on 29.06.2022 in course of my Evening Mobile van duty I received one secret source information to the effect that one person is carrying huge quantity of liquor illegally and through Pakurtala More towards Bhutia Market Siliguri. Accordingly the information shared to O/C, Panitanki TOP and thereafter as per his direction I along with, Const/114 Naresh Hasda, CV-1007 Jiten Roy arrived at Pakurtala More near Agragami Club , Siliguri at 20.45 hrs being pointed out by the source, found that one person is proceeding with huge quantity of liquor containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of available witnesses. During interrogation the accused failed to produce any documents/license in support of the same and stated that he sale the same to the local public at Pakurtala More near Agragami Club adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized the above noted articles under proper seizure list and labelled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made between 21.05 hrs to 21.45 hrs on 29.06.2022. Then I arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. The local public was also annoyed with him because of his this kind of illegal activities. As such there was no scope to serve Notice u/s 41A of Cr.P.C.

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Sujon Mardi (M/20), S/O Sri Joseph Mardi of Village Kolohori, Balurghat, PO-Chand Ganj, PS-Kumar Ganj, Dist- Dakhin Dinajpur A/P Shib Nagar near Gass Godown, Darjeeling More, PS-Matigara, Dist- Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
