- (iii) 02 (Two) bottles of Tuborg Premium Beer ( each bottle containing 650 ML)


I, PSI Rantu Haldar of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 28.06.2022 while performing special raid duty under Bhaktinagar PS area vide BKN PS GDE No. 1483 Dated. 29.06.2022 at about 16.05 Hrs I, received a source information that the above noted accused person have possessed huge quantity of Liquor in his shop for the purpose of selling the same to her designed Customers at back side of Bishal Cinema Hall under Bhaktinagar PS. Accordingly I shared the information to I/C Bhaktinagar P.S/SPC as per his direction I, along with CV/614 Sumit Kr Roy CV/614 Dharmendra Roy and LCV/1060 Goma Bhandari headed towards back side of Bishal Cinema Hall to verify the veracity of the information. We reached at back side of Bishal Cinema Hall as shown and being identified by the source held raid and apprehended one person who disclosed her identity as noted above. Further maintaining her decency and observing all formalities and with the help of LCV/1060 Goma Bhandari searched her and recovered above noted seized liquor from her possession. On demand She failed to produce any valid documents/licence in respect of the recovered liquors. On interrogation the apprehended person admitted her guilt and confessed that She has possessed above noted liquor in his shop for the purpose of selling to his designed customers for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made in between 16.45 Hrs to 17.25 Hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the accused her u/s 41 Cr.P.C appraising his ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Lata Paul @ Jhuma (F/40) W/O Lt Hiten Ch Paul of Back side of Bishal Cinema Hall, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and arrange for its investigation.
