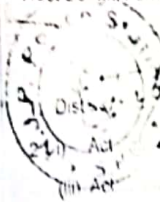

Sub: FIR regarding attempted theft and breakage of rear glass of my car (BR-01 BG/8587) while parked in the campus of Railway Hospital, NJP between 10:30 to 11:30 Hrs of 26.06.2022.

I, Arvind Kumar Mishra, S/O Shri Chandeshwar Mishra working as Director/Darjeeling Himalayan Railway and residing at Railway Bungalow No: 366/A, Railway Officers Colony, NJP had parked my car bearing No: BR-01 BG/8587 in the campus of Railway Hospital, NJP at about 10:30 Hrs of 26.06.2022 in order to see my ailing father who is an indoor patient in male surgical ward of the hospital. Having met my father when I returned back to my car at about 11.30 Hrs I saw that rear most glass of the car was broken and depleted. There were signs of attempted breakage of the windshield at the right side of the driver seat also. However, nothing from inside was found missing as nothing costly was available inside. The occurrence took place in broad daylight at a public place like Railway hospital.

Therefore, it is kindly requested to lodge an FIR and investigate the matter to book the culprits in order to prevent any recurrence of such nature please.
