In producing herewith one accused person namely Pranab Das (20 yrs), S/O- Rajen Das Of Takimari, PO- Milanpally, PS- NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 08(Eight) Bottles of Galaxy Boss 60 up country spirit containing 600 ML each.
2. 01(One) bottle of Royal Stag Blended Whisky containing 375 ML.
3. 01(One) bottle of Royal Stag Blended Whisky containing 180 ML.
4. 02(Two) Bottles of Imperial blue classic grain whisky containing 180 ml. each.
5. 01(One) Bottle of Officer choice Deluxe Whisky containing 375 ml.
6. 01(One) Bottle of Officer choice Deluxe Whisky containing 180 ml.
7. 01(One) Bottle of Mc Dowells No1 Rum Containing 180 ML.
8. 01(One) Bottle of Tuborg Premium Beer Containing 650 ML.

I ASI Biswajit Adhikari of Milanpally out post under NJP PS do here by lodged a written complaint to the effect that today on 27.06.22 at 18:15 hrs acting on a tip-off source information myself along with C/-1052 Dipak Das, VP 12 Dasarath Roy had been to Takimari under Milanpally OP to work out the information that a huge number of country spirit are stocked in the shop of one Pranab Das Of Takimari, PO- Milanpally, PS- NJP, Dist- Jalpaiguri without license to sale the same in the open market. This refers to Milanpally out post GDE No- 617, DT-27.06.22. On arrival at Takimari Bazar at 18.35 hrs and I called two local witnesses to witness the raid and on being identified by the engaged source we held raid in the shop of Pranab Das and could recover the above noted of liquor. During raid the above noted accused person was arrested from whose exclusive possession the above noted liquors were found. On demand he could not produce any license/documents in support of his possession. On interrogation he admitted that he has been running the business clandestinely since long. Accordingly I seized the above noted liquors under proper seizure list and arrested the accused person U/S - 41 Cr.P.C and took him into the custody. The seizure was made in between 18.50 hrs to 19.35 hrs.

Hence, I pray that a specific case under proper section of law may kindly be initiated against the accused person namely Pranab Das (20 yrs), S/O- Rajen Das Of Takimari, PO- Milanpally, PS- NJP, Dist- Jalpaiguri.
