Sir,

In producing herewith one accused person namely Sanjit Mandal (48yrs) S/o. Lt. Kalachand Mandal of Mahamaya Colony, PO-Karmarvita, PS-NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:


1. 15(fifteen) Bottles of 60 Up Galaxy Boss Country Sprit each bottle containing 600 ML.
2. One nylon Bag which was used to store the above noted articles.

I, SI. Rakesh Debnath of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 27.06.2022 at 19:35hrs received a source information from Ambari Hat Bazar that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE 950 dated 27.06.22. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) ASI. Biswajit Ghosh (2) C/505 Tapash Dutta (3) VP-14 Paritosh Ray and (4) CV/340 Susen Biswas all of Ambari-Falakata OP, Under NJP PS/SPC proceeds to Ambari Hat Bazar to work out the information. At 19:45 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Ambari Hat Bazar and recovered the above noted articles from the possession of accused person namely Sanjit Mandal (48yrs) S/o. Lt. Kalachand Mandal of Mahamaya Colony PO-Karmarvita, PS-NJP, Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person In presence of witnesses namely 1) Abhijit Majumder S/o. Lt. Ajit Majumder of Ambari-Falakata, PO. Karmarvita, PS. NJP, Dist-Jalpaiguri and 2) CV-963 Tapan Roy of Ambari-Falakata OP, under NJP PS/SPC after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 20:45 hrs to 20:55 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Sanjit Mandal (48yrs) S/o. Lt. Kalachand Mandal of Mahamaya Colony, PO-Karmarvita, PS-NJP, Dist- Jalpaiguri under proper section of law.
