Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Gobinda Mahato (24) s/o Lt. Jitu Mahato of South Shantinagar, PS-NJP, Dist.- Jalpaiguri (ii) Ananta Sarkar (25) s/o Lt. Samar Sarkar of South Shantinagar, PS- NJP, Dist.- Jalpaiguri (iii) Om Nath Mishra (28) s/o Laxman Mishra of Debari, PO+PS-Pandal, Dist.- Madhubani, Bihar A/P NJP Station area, P.S- NJP, Dist.- Jalpaiguri (iv) Rabi Shankar Mahato s/o Panchan Mahato of Basanpur, PS- Kesow, Dist.- Purnia, Bihar A/P Fuleshwari, P.S- NJP, Dist- Jalpaiguri and and the following articles under seizure :-

- 1 One iron made sharp cutting weapons called as Hasua and one touch light and one screw driver from the possession of accused Gobinda Mahato (24) s/o Lt. Jitu Mahato of South Shantinagar, PS-NJP, Dist.- Jalpaiguri.
- 2 One iron made sharp cutting weapons called as Bhojali from the possession of accused Ananta Sarkar (25) s/o Lt. Samar Sarkar of South Shantinagar, PS- NJP, Dist.- Jalpaiguri
- 3 One sharp cutting knife and one torch light from the possession of accused Om Nath Mishra (28) s/o Laxman Mishra of Debari, PO+PS-Pandal, Dist.- Madhubani, Bihar
- 4 One sharp cutting Bhojali and one torch light from the possession of accused Rabi Shankar Mahato s/o Panchan Mahato of Basanpur, PS- Kesow, Dist.- Purnia, Bihar.

I, ASI Sajal Das of NJP PS, Siliguri Police Commissionerate beg to state that on 28.06.2022 at 01:25 hrs received a secret source information that that a gang of miscreants come at near Ambikanagar Bazar, PS- NJP, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Ambikanagar Area. Accordingly, I diarised the fact in General Diary vide NJP PS GDE No 1350 dated 28.06.2022 and informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC about the information. I also informed the fact to night RT Van officer ASI Pranab Majumdar and requested them to come to Ambikanagar to accompany with us. At 01:45 hrs we arrived at near Ambikanagar Bazar under PS- NJP, Dist.- Jalpaiguri and ambush there. After a few time RT Van officer ASI Pranab Majumdar along with force came to near Ambikanagar and accompany with us. At about 02:35 hrs as indicated by the source we noticed that 08/09 persons assembled in a dark place near Ambikanagar, PS- NJP, Dist.- Jalpaiguri and they were whispering in a very low voice. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully but seeing the police party they started to flee away but we the police party managed to apprehended 04 (Four) of them with deadly weapons in their possession. On interrogation the apprehended accused persons disclosed their name and identity as noted above.

During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presene in middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity at Ambikagar area. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested the above noted 04 (Four) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure and arrest made in between 02:35 hrs to 03:15 hrs on 29.04.2022.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Gobinda Mahato (24) s/o Lt. Jitu Mahato of South Shantinagar, PS-NJP, Dist.- Jalpaiguri (ii) Ananta Sarkar (25) s/o Lt. Samar Sarkar of South Shantinagar, PS- NJP, Dist.- Jalpaiguri (iii) Om Nath Mishra (28) s/o Laxman Mishra of Debari, PO+PS-Pandal, Dist.- Madhubani, Bihar A/P NJP Station area, P.S- NJP, Dist.- Jalpaiguri (iv) Rabi Shankar Mahato s/o Panchan Mahato of Basanpur, PS- Kesow, Dist.- Purnia, Bihar A/P Fuleshwari, P.S- NJP, Dist- Jalpaiguri and others and arrange for its investigation.
