In producing herewith one accused person namely Dulal Roy (40 yrs), s/o - Lt. Jagmohan Roy of Mohanvita, PS - Rajganj, Dist - Jalpaiguri along with the following seized articles as per proper seizure list:

1. 12 (twelve) bottles of Himalayan Gold 60 up Country Sprit each bottle containing 600 ml.

1. SI. Kamal Saha of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 28.06.2022 at 16:15hrs received source information from Sitaguri under Ambari Falakata OP that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. At 16:55 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Roy Hotel, Sitaguri near Bharat Petrol Pump and recovered the above noted articles from the possession of accused person namely Dulal Roy (40 yrs), s/o - Lt. Jagmohan Roy of Mohanvita, PS - Rajganj, Dist - Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor.
