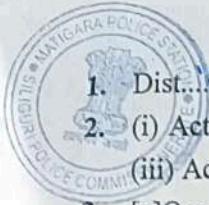

**Subject: FIR**

Sir,

In producing herewith 05 (Five) arrested accused persons namely (i) Amit Thapa (25) S/O Lt. Ashok Thapa of Tindharia Cricket Bazaar, PO+PS- Kurseong, Dist-Darjeeling (ii) Raja Sow (33) S/O Lt. Jogender Sow of Mahamaya Colony, 9 no. road, ward no. 47, PO-Matigara, PS-Matigara, Dist-Darjeeling, (iii) Manoj Das (25) S/O Monu Das of Krishnanagar Colony, PO-Sahudangihat, PS-Bhaktinagar, Dist-Jalpaiguri (iv) Sanjay Dey (21) S/O Haren Dey of Sukantapally Colony PO-Pradhannagar, PS- Matigara, Dist-Darjeeling and (v) Manab Barman (18) S/O Bhombol Barman of Nehalujote, Patharghata, PO-New Chumta, PS-Matigara, Dist-Darjeeling (arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (i) One iron made 'Knife' found from the possession of Amit Thapa which was kept in his right hand.
- (ii) One iron made 'Kukri' found from the possession of Raja Sow which was kept on his right hand.
- (iii) One iron made Crowbars found from the possession of Manoj Das which was kept on his right hand.
- (iv) One sharp cutting weapon called as Hasua recovered from the possession Sanjay Dey which was kept on his right hand.
- (v) One iron made sabol and one torch light found from the possession of Manab Barman which was kept on his right hand.

I, PSI Agen Lepcha, S/O- Dup Tshering Lepcha of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Amit Thapa (25) S/O Lt. Ashok Thapa of Tindharia Cricket Bazaar, PO+PS- Kurseong, Dist-Darjeeling (ii) Raja Sow (33) S/O Lt. Jogender Sow of Mahamaya Colony, 9 no. road, ward no. 47, PO-Matigara, PS-Matigara, Dist-Darjeeling, (iii) Manoj Das (25) S/O Monu Das of Krishnanagar Colony, PO-Sahudangihat, PS-Bhaktinagar, Dist-Jalpaiguri (iv) Sanjay Dey (21) S/O Haren Dey of Sukantapally Colony PO-Pradhannagar, PS- Matigara, Dist-Darjeeling and (v) Manab Barman (18) S/O Bhombol Barman of Nehalujote, Patharghata, PO-New Chumta, PS-Matigara, Dist-Darjeeling and others to the effect that today on 30.06.2022 at 01:05 hrs received a sources information that 12/14 youths have assembled at Chowrangi More Patiramajote under Matigara PS with a view to commit dacoity in a house at Patiramajote area. Accordingly the matter was diarized in general diary vide Matigara PS GDE No. 1534/22 dated 30/06/2022. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Tapan Das, C/1053 Paresh Rava, CV/387 Sukumar Barman and C/974 Mintu Sen, all of Matigara PS, SPC, left for the place to work out the information. I also informed the RT van officer to come to the Chowrangi More near Ptiramajote. At about 01:40 hrs after reaching near Chopwraangi More under PS- Matigara I met my source and being pointed by the source we started walking towards Chowrangi More. By this time the van officer and force also came at the spot. At 01:50 hrs. we reached at Chowrango More and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot after seeing police personnel approaching towards them. They tried to fled away but on hot chase and with the help of van officer and force we managed to apprehend above noted 05 (five) accused persons along with seized articles as mentioned above from their possession. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation all the accused persons admitted that they had assembled there to commit dacoity in a house at Patiamjote area.

I thereafter, seized the above noted weapons under proper seizure list in presence of witnesses duly acknowledged by the accused persons. The whole seizure was made in between 02:20 hrs to 03:25 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Patiramjote area. It is also revealed from them that some others have assembled there along with them and had planned for committing the dacoity but managed to flee away.

Hence, a specific case may kindly be started under proper section of Law against the arrested accused persons namely (i) Amit Thapa (25) S/O Lt. Ashok Thapa of Tindharia Cricket Bazaar, PO+PS- Kurseong, Dist-Darjeeling (ii) Raja Sow (33) S/O Lt. Jogender Sow of Mahamaya Colony, 9 no. road, ward no. 47, PO-Matigara, PS-Matigara, Dist-Darjeeling, (iii) Manoj Das (25) S/O Monu Das of Krishnanagar Colony, PO-Sahudangihat, PS-Bhaktinagar, Dist-Jalpaiguri (iv) Sanjay Dey (21) S/O Haren Dey of Sukantapally Colony PO-Pradhannagar, PS- Matigara, Dist-Darjeeling and (v) Manab Barman (18 ) S/O Bhombol Barman of Nehalujote, Patharghata, PO-New Chumta, PS-Matigara, Dist-Darjeeling Dist-Darjeeling and others and arrange for its investigation.


