I, Punam Sahani Singh, W/o Mohan Kumar Singh , D/o Suresh Sahani presently residing at Himanta Basu Colony, P.O & P.S Siliguri , Dist Darjeeling, Pin - 73400 would like to inform you that I am legally married wife of Mohan kumar Singh S/o of Lal Bahadur Singh , permanent resident of Nandapati Antuar , Darbhanga , Pin - 847103, Bihar and our marriage was in accordance with Hindu rites and customs on 6/12/2014 at Siliguri .

After marriage I started conjugal life with my Husband in my in-laws house. That since after marriage , I came to know that my husband has an habit of taking drugs and drinking alcohol and for that he used to abuse me and torture me without any reasons and also beat me by slaps and punches and when I tried to stop him then he also beat me by wooden Batam. When I complained to my in laws about their son's inhuman behavior on me, then they did not take any action against their son.

In between I became pregnant and gave birth of a Female child , namely Vesnavi Kumari in the month of 21/09/2015 In spite of happened the above incident for leading happy conjugal life . I used to tolerate all inhuman behaviour of my husband, my in-laws. After few years I got pregnant for the Second time and I was very happy for that but after 7th months of my pregnancy my husband and my in laws ,that my father in law namely Lal Bahadur singh and also my brother in laws namely Manoj singh and Saroj singh and also theirs wifes namely Munni singh and Mili Singh had forced me for abortion of my child who was in my womb. But after consultation with the doctor my husband and his family members came to know that it would be very risky for me and my life because my pregnancy period was over of 7th months. When I denied to do

abortion my husband and his family members again started torturing me and beat me and throw hot tea on me inspite of knowing that I am pregnant. After that one day my husband attempted to kill me by pouring kerosene oil on me and put fire, but luckily I got safe by the neighbours . After trying to everything for abortion of my child my husband and his family members also started torturing me and tried to kill my baby who was in my womb and they call my parents to bring me in my parental house. I came back to my parental house at Siliguri, where I gave birth my female child namely Saraswati Singh in the month of 09/07/2018 , after hearing this news they deny to take me back to their house and also told me that if I kill my girl child then only they take me back otherwise not. After 3 years birth of my child they neither call me nor came to my parental house for looking us how me and my two girl child are spending our days.

So, it is humbly request you to take the necessary legal steps regarding the above stated facts.
