With due respect, I am producing herewith 05 (five) arrested accused persons namely (i) Md Alamgir (21 yrs) 5/0 Late Md Alam of Biswas Colony, PS- Matigara, Dist.- Darjeeling (ii) Sahadeb Roy (27 yrs) S/O Angaru Roy of Roy Colony, Chayan Para, Ward No-42, PS- Bhaktingar, Dist.- Jalpaiguri (iii) Rohan Chhetri (22 yrs) S/O Late Milan Chhetri of Chowrasta, Bhutia Busty, PS- Sadar, Dist. Darjeeling A/P residing at Biswas Colony, PS- Matigara, Dist.- Darjeeling (iv) Rajesh Pradhan (28 yrs) S/O late Tek Bahadur Pradhan of Chayan Para, Sarba Pally, PS- Bhakti Nagar, Dist.- Jalpaiguri and (v) Md Jiarul (27 yrs) S/O Md Boga Mia of Biswas Colony, PS- Matigara, Dist.- Darjeeling and the following articles under seizure:

1. One iron made sharp cutting knife recovered from the possession of accused Md Alamgir (21 yrs) S/O Late Md Alam of Biswas Colony, PS- Matigara, Dist.- Darjeeling.

2. One iron made sharp cutting knife and one torch light recovered from the possession of accused Sahadeb Roy (27 yrs) S/O Angaru Roy of Roy Colony, Chayan Para, Ward No-42, PS- Bhaktingar, Dist.- Jalpaiguri.

3. One iron made sharp cutting weapon called as Bhojali recovered from the possession of accused Rohan Chhetri (22 yrs) S/O Late Milan Chhetri of Chowrasta, Bhutia Busty, PS- Sadar, Dist. Darjeeling A/P residing at Biswas Colony, PS- Matigara, Dist. Darjeeling.

4. One sharp cutting weapon called as Hasua and one torch light recovered from the possession accused Rajesh Pradhan (28 yrs) S/O late Tek Bahadur Pradhan of Chayan Para, Sarba Pally, PS- Bhakti nagar, Dist.- Jalpaiguri.

5. One Sharp cutting knife and one Sabol recovered from the possession of accused Md Jiarul (27 yrs) S/O Md Boga Mia of Biswas Colony, PS- Matigara, Dist.- Darjeeling.

I, SI Uday Chakraborty of Matigara PS, Siliguri Police Commissionerate beg to state that on 02.07.22 at 01.15 hrs received a secret source information that that a gang of miscreants come at Biswas Colony under PS- Matigara, Dist.-Darjeeling with deadly weapons and assembled there and making preparation for committing dacoity at Matigara Bazar area. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 58 dated 02.07.22 and informed the fact to you. As per your order I along with C/ 974 Mintu Sen, C/1053 Paresh Rava, CV-155Sukumar Das, CV- 387 Sukumar Barman all of Matigara PS ,SPC left PS to verify the veracity of said source input. I also informed the fact to Night RT Van officer SI Md Sanaulla and ASI Nirmal Kr Singha and requested them to come to Biswas Colony to accompany with us. At 01.35 hrs we arrived at Biswas Colony under PS- Matigara, Dist.- Darjeeling. After a few time RT Van Officer SI Md Sanaulla and ASI Nirmal Kr Singha along with force came to near Biwas Colony and accompany with us. At about 01.55 hrs as indicated by the source we noticed that 08/10 persons assembled in a dark place at Biswas Colony under PS- Matigara, Dist.- Darjeeling and they were whispering in a very low voice. Accordingly, we cordoned the place properly and carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 05 (Five) of them with deadly weapons in their possession. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity in a house at Matigara Bazar area. On search the above noted weapon of offence recovered from their possession. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested above noted 05 (Five) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to Matigara PS. The search seizure and arrest made in between 02.35 hrs and 03.45 hrs on 02.07.22.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the above noted arrested accused persons namely (i) Md Alamgir (21 yrs) S/O Late Md Alam of Biswas Colony, PS- Matigara, Dist.- Darjeeling (ii) Sahadeb Roy (27 yrs) S/O Angaru Roy of Roy Colony, Chayan Para, Ward No-42, PS- Bhaktingar, Dist.- Jalpaiguri (iii) Rohan Chhetri (22 yrs) S/O Late Milan Chhetri of Chowrasta, Bhutia Busty, PS-Sadar, Dist.
