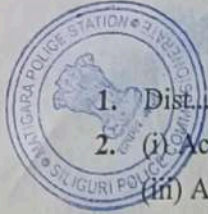

Sir,

In producing herewith one accused person named Dilu Chhetri (39 yrs) S/O Shyam Bdr Chhetri of Matigara Bazar, PO+PS- Matigara, Dist- Darjeeling along with following articles under proper seizure list :-

(i) 13 (Thirteen) bottles of 'Himalayan Gold 60 UP' Country Spirit containing 600 MI in each bottle and value of Rs 120/- of each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".

I, PSI Shekhar Adhikary of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Dilu Chhetri (39 yrs) S/O Shyam Bahadur Chhetri of Matigara Bazar, PO+PS- Matigara, Dist- Darjeeling to the effect that on 01.07.2022 at 19.15 hrs received a source information that one person named Dilu Chhetri of Matigara Bazar is selling liquor at his residence at Matigara Bazar without any valid license. Accordingly, the fact was diarized in General Diary vide Matigara PS GDE No 45 Dated 01.07.2022 and shared the information with O/C Matigara PS and as per his kind order and direction myself along with force had been to Matigara Bazar to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the residence of accused Dilu Chhetri at Matigara Bazar and managed to apprehended him. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor at his residence without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from the house of the said accused. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Dilu Chhetri (39 yrs) S/O Shyam Bdr Chhetri of Matigara Bazar, PO+PS- Matigara, Dist- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 01.07.22 in between 20.35 hrs to 21.15 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against arrested accused Dilu Chhetri (39 yrs) S/O Shyam Bdr Chhetri of Matigara Bazar, PO+PS- Matigara, Dist- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
