I, SI Abhishek Theengh of Pradhan Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Mithu Saha (33), S/O- Sri Narayan Saha of Gate Baazar, PS Pradhan Nagar, Dist Darjeeling to the effect that today on 29.06.2022 at 15.25 hrs received a source information that one person named is selling liquor in a shop situated at Gate Baazar area under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction I along with CV/128 Ajay Sahani, CV/646 Baban Das had been to Gate Baazar area under Pradhan Nagar PS to verify the veracity of source information. Then I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Mithu Saha (33), S/O- Sri Narayan Saha of Gate Baazar, PS Pradhan Nagar, Dist Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 15:55 hrs to 16.25 hrs at the spot and arrested him after informing the ground of arrest.
