In producing herewith one accused person named Raghunath Das (62 yrs) S/O late Khokaram Das of Matigara Bhanga Pool, PO+PS- Matigara, Dist- Darjeeling along with following articles under proper seizure list :-

(i) 12 (Twelve) bottles of 'Himalayan Gold 60 UP' Country Spirit containing 600 ML in each bottle and value of Rs 120/- of each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".


I, SI Goutam Mallik of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Raghunath Das (62 yrs) S/O late Khokaram Das of Matigara Bhanga Pool, PO+PS- Matigara, Dist- Darjeeling to the effect that on 01.07.2022 at 18.45 hrs received a source information that one person named Raghunath Das of Matigara Bhanga Pool, PO+PS- Matigara, Dist- Darjeeling is selling liquor at his Hotel situated at Paribahan Nagar under PS - Matigara, Dist.- Darjeeling without any valid license. Accordingly the fact was diarized in General Diary vide Matigara PS GDE No 43 Dated 01.07.2022 and shared the information with O/C Matigara PS and as per his kind order and direction myself along with force had been to Paribahan Nagar to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the hotel of accused Raghunath Das S/O late Khokaram Das of Matigara Bhanga Pool, PO+PS- Matigara, Dist- Darjeeling situated at Bhanga Pool, PS- Matigara, Dist.- Darjeeling and managed to apprehended him. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor in his hotel without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from the house of the said accused. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Raghunath Das (62 yrs) S/O late Khokaram Das of Matigara Bhanga Pool, PO+PS- Matigara, Dist- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 01.07.22 in between 19.45 hrs to 20.25 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against arrested accused Raghunath Das (62 yrs) S/O late Khokaram Das of Matigara Bhanga Pool, PO+PS- Matigara, Dist- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.


