Sir,

In producing herewith one accused person named Umesh Mandal (36), S/O- Kamal Mandal of Siliguri Junction Ward No. 01, PS Pradhan Nagar, Dist Darjeeling under arrest along with following articles under proper seizure.

1. 28 (Twenty Eight) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 8.4 liters) (Out of which one has been taken as sample for examination)
2. 20 (Twenty) sachet of Officer's Choice Deluxe Whisky (each bottle containing 180 ml, Total 3.6 liters) (Out of which one has been taken as sample for examination)

I, SI Abhishek Theengh of Pradhan Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Umesh Mandal (36), S/O- Kamal Mandal of Siliguri Junction Ward No. 01, PS Pradhan Nagar, Dist Darjeeling to the effect that today on 01.07.2022 at 17.35 hrs received a source information that one person named is selling liquor in a shop situated at Siliguri Junction area under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction I along with PSI Bijoy Sarkar, PSI Bandahn Roy, CV/242 Rakesh Mangar and CV/128 Ajay Sahani had been to Gurung Busty near Ramnarayn Mat under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that one person was selling and storing illicit distilled liquor at his shop. Subsequently, I along with my force cordoned the shop and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Umesh Mandal (36), S/O- Kamal Mandal of Siliguri Junction Ward No. 01, PS Pradhan Nagar, Dist Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 17:55 hrs to 18.45 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Umesh Mandal (36), S/O- Kamal Mandal of Siliguri Junction Ward No. 01, PS Pradhan Nagar, Dist Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
