Sub: A Complain of cruelty against wife.

Respective Sir,

Received on-23.06.22 With due respect I beg to state that, I Sangam Temani, W/o Rahul at 23.05 km. Temani, D/o. Pawan Kumar Agarwal, resident of Flat No. 302, Block-D, Mayfair vide GDF no- 1195 Dt-23.06.22 Crown Residency, Zilla Parishad Road, Jyotinagar, Siliguri - 734001 got married to Rahul Temani on 18th January, 2014. At the time of my marriage my father gave a dowry of Rs. 10,00,000/- (Ten Lakh) cash and gold of 100 gm. Worth of Rs. R,4,00,000/- (Four Lakh) and other furnitures required to decorate a house worth of Rs. 4,00,000/- (Four Lakh) as demanded by the below mentioned accused persons. After the marriage I went to my in-laws house and started our conjugal life with my husband. That after the marriage a few months of our conjugal life was running smoothly. During down conjugal life one female child was born named Chahak Temani and aged about 6 years now. After the birth of female child accused persons demanded Rs. 10,00,000/- (Ten Lakh) more from my parents on refusal of paying money by my father they started torturing me both physically and mentally. After that we shifted Siliguri from Dhupguri in the year of 2018. But after all accused persons came to Siliguri and tortured me both physically and mentally my brother in law and his wife namely Kamalesh Temani and Aarti Temani along with husband forcefully broke my wardrobe and stole all the valuables from it and locked me and my daughter in that room for around 3 (Three) days without food and water. This tortures were going on and on when all of a sudden on 19th February 2022 my husband eloped. On not returning to back to home on 19th, I immediately filed a missing diary at Bhatinagar P.S. on 20th February whose no is GDEE 934/22. After waiting for months, we finally got the information that my husband is in Dhupguri residing with his parents and brother. My husband purposely abandoned me and my daughter and left us helpless without any financial aid. My husband under the influence of his family members is intentionally trying to plot a conspiracy against us.

Suresh Temani is my father in law. He is a regular drinker and he has supported his wife in torturing me a lot. One we went to Jammu and Kashmir where he tortured me so much that I can never forget that day. He used to always taunt me by the name of the father. He has also tried to abuse me physically many times and that's the reason I didn't go to Dhupguri since 2018. He used to use sly language for me and my parents and also demand money from them from time to time.

Kiran Temani my Mother in Law is the main reason for all this in my life. She use to teach my husband wrongs thing and complain about me on that he use to beat me a lot. She used to torture me to bring things from my home. When I was about to deliver my baby then also she was against operation where as the doctor said that the child is stuck inside. Still she was against it. And even after my delivery she made me so much work that I started having never problem in my right leg. She uses to motivate Rahul to beat me a lot. She use to Harass my Mom and Dad by calling them and saying anything. Now also she is torturing me by taking names of God. She has not yet stopped. Still I am getting calls in the name of Gods, Where in they try to tell me to leave the home with my daughter and go somewhere.

Rahul my husband had started torturing me just after my marriage. He used to beat me a lot, no matter what the place is, he has beaten me at home, in car and also in train while travelling to Guwahati. He used to say abusive words for my father. When we have our daughters then also he was like how did we get a daughter, why not a son. My daughter has seen all his torture. Though for the world he is handicapped but then also he use to beat me a lot with his legs and hand too. He even had extra marital affairs with some of his friends. He dint have time for me but he always had time for them. He has beaten me so many times in front of my daughter also. At last my daughter was also fed up and said me why I was living with him. Now she also doesn't want to say with him. He has run away from home many times even when his health was good. He use to torture me to take money from my day. He has also taken loan on my mother's FD. He has also insisted me to take papers of my father's home, so that he can take loan on it. But we denied that in our new flat, he had also taken cash from my father. He has demanded money from my dad many times. He is still torturing me by call me from different number asking for OTP as a bank manager.

Kamalesh Temani, my brother in Law used to torture me after my marriage by throwing food and telling me abusive things. He was also not interested in going to office where he used to work. He used to stay at home all throughout the day and torture me. He also tried to hit me many times. When my husband went missing on 29th February 2022, he along with his wife Aarti Temani came to my flat on 20th February 2022 and started shouting at me, they even try to hit me, both of them pushed me and my daughter Chahat. Both of them threw my home items here and there and also opened my Locker. But as I was so worried about my husband so I couldn't stop them. I was not in my senses at that time. Aarti Temani, wife of my Brother in Law (Kamlesh Temani). I had not met her before but she also came along with her husband on 20th February 2022 to my flat and started torturing me. Started shouting at me. Infact she tried to threaten me over phone from Rajasthan by her father and mother. And my in-laws gave all my Jewelleries to her.

Manoj Agarwal and Sunita Agarwal (Parents of Aarti Temani), I dint knew them as in my brother-in-laws marriage I was not invited. My husband went to attend the marriage leaving me and my daughter behind. Two months before they called me to ask about my health as my in-laws had told them that my back was operated and had a daughter of 6 months so was unable to attend the marriage. I never met them but after Rahul went missing they called me many times via whatsapp call by different names of God and told me to leave the house and go somewhere else leaving this flat or else they threatened me that they will destroy me and my family. They always try to frighten me and motivate me to leave my house.

Hence forth, it's my humble request before you to take immediate action against them.
