I, Sri.Sumanta Ghosh, Son of Sri.Swapan Kumar Ghosh, resident of "Nanda", Sukanta Nagar, Ward No.38 of S.M.C., P.S.Bhaktinagar, Dist. Jalpaiguri, would like to lodge this written complaint against one of our neighbor namely Rick Basak, son of Gopal Basak resident of "Saha view" Sukanta Nagar, Ward NO.38 of S.M.C., P.S.Bhaktinagar, Dist. Jalpaiguri, as follows:-

That I am an advocate by profession and while returning from court I came to my house at about 8.15 p.m. today and said boy namely Rick Basak was standing in the middle of our road and when I told him to give a side he was very adamantly standing in the middle of the road and did not give me side but somehow I cross the road and came to my house and suddenly the said boy came in front of my house when I was opening my main gate.

That out of bloom he suddenly appeared behind me and punched me in my back and due to that sudden attack I fell down on the ground and I shouted for help my wife namely Anima Besra came out of the house to rescue me and at that moment he took out a sharp blade from a match box from his pocket and attack me with that sharp blade and tried to kill me and at that he used it to hit me on my neck to cut my throat and I somehow rescued myself but during that course I was injured by that said blade.

When my wife tried to resist him he pushed my wife for which she fell down on the ground and thereafter he kick on her stomach for which she also suffered injury to her stomach and her right hand but I resisted her. Due to the hue and cry made by us the neighbor and my parents came out of the house and rescued us from him and he fled away by threatened us with dire consequences.

Sir, I therefore you are therefore requested to take appropriate legal action against said Rick Basak, son of Gopal Basak for which I shall be highly obliged to you.
